MEMORIAL DAY OBSERVANCE

The speaker recognized Representative B. Turner who presided over the memorial day ceremonies.

The house and gallery stood while the colors were posted.

Representative B. Turner recognized Representative Willis who addressed the house and asked members of the house who were affiliated with the military to stand and be recognized.

Representative Willis introduced Representative B. Turner, Representative R. Cuellar, Representative Counts, Representative Price, Representative Walker, and Representative Yarbrough, members of the House Select Committee on the Military.

Representative B. Turner introduced officers and staff of the Texas Air National Guard and Texas Army National Guard and their families.

The house and gallery stood and recited the pledge of allegiance.

The house and gallery remained standing while the colors were retired.

Representative B. Turner introduced Adjutant General Sam Turk who addressed the house speaking as follows:

Speaker Laney, distinguished members of the Texas legislature, honored guests, ladies and gentlemen: we're gathered today to commemorate Memorial Day, 1995, a day of remembrance for those who have died in the service of our great nation. Memorial Day was first widely observed on May 30, 1868, when General John Logan, Commander in Chief of the Grand Army of the Republic, ordered that flowers be placed on the graves of soldiers who had died during the Civil War. This special time was originally devoted to honoring only those who had fallen during the Civil War, but today we honor all of our men and women who have died as a result of war.

It's a sad fact of our nation's history that since that time, many have been asked to make the ultimate sacrifice while serving our great nation. From San Juan Hill in Cuba during the Spanish American War, through the countryside of France during World War One, across the islands of the Pacific and throughout Europe during the Second World War, Korea, Vietnam, Lebanon, Grenada, Panama, the Persian Gulf—all diverse locations around the world that share the common bonds of witnessing the final gallant moments of an American soldier or sailor or airman or marine or coastguardsman as they gave their lives and paid the ultimate price for freedom and democracy. While we gather today to mourn the loss of these fine Americans, let us also honor them by remembering why they fought. For America is different from the world powers that have come before us. We have never gone to war to conquer territory. We have never sacrificed our men and women in battle in order to enslave or subjugate a foreign nation. Throughout its history, America has given up her sons and daughters for the sake of world peace and world freedom. Rather than trying to conquer or suppress, our goal has always been to defend and to assist. As such, America has evolved into something unique in the annals of history. A nation willing to use its military, its military power, for the good of humankind. We've asked our servicemen and our servicewomen to pay a very steep price indeed, but the causes have been just.

Today, the veterans to whom we pay special tribute are much more than names on a tombstone. They are symbols of our march towards a time when justice, democracy, and freedom will hopefully reign around the world. This is a special time, for this year we mark the fiftieth anniversary of the end of the greatest tragedy that mankind has ever known—the Second World War. As we commemorate our great global victory, let us also remember the gallantry of those who fell. Let us remember Private First Class Charles Howard Roan from Claude, Texas. Private Roan served in the Second Battalion, First Marine Division in the Pacific. On September 18, 1944, Private Roan and his squad were partly cut off from their company by surprise Japanese attack. They found themselves engaged in a very furious exchange of hand grenades with Japanese forces that were in place in a cave on higher ground and to the rear of the squad. While seeking protection with his companions, Private Roan was wounded by an enemy grenade that fell near his position. When another grenade landed in the middle of his group, Private Roan, without hesitation, immediately threw himself upon it, covering the grenade with his body, and absorbing the full impact of the explosion. His prompt, heroic action and selfless conduct saved the lives of everyone else in the squad, but caused him to lose his own. Private First Class Charles Howard Roan of Claude, Texas, posthumously received the congressional medal of honor for his heroic actions. May we never forget the valor of Private Roan or the millions of other men and women who have served our great nation and given so much.

As we remember them, I ask you to look around. Look at the veterans of war because they're all different. You may tell the difference by their medals or by the size of the individual or the age, or even how much hair they have left. But you can't tell the difference by their devotion to duty and their love of country, for there is no difference. Look into their eyes. Whatever war they served in, you see a tear—a tear for a fallen comrade. But you see hope—hope for lasting peace. Now let us look into the eyes of our servicemen and servicewomen and let us say to them: We are a grateful nation; we remember now and will continue to remember you always.

Thank you for the honor and privilege of being here today. May God bless you all, may He bless Texas, and may God bless the United States of America. Thank you very much.

Buglers Captain John Bohlin, Texas Army National Guard, and Thomas Serres, Boy Scout Troop 399, sounded taps.

The benediction was given by Army National Guard Chaplain Lieutenant Colonel Rodney Coleman.

No more than seven licensed authorized organizations may conduct bingo at any bingo premises. [~~A game conducted under a temporary license may not be conducted in violation of this section.~~]
