The invocation was offered by James Borchert, pastor, Emmanuel Christian Fellowship, Fort Worth, as follows:

Father in Heaven, we call upon your great and gracious name for today's high business which is to be conducted in this worthy assembly. First and foremost, we give thanks for our many and various blessings, which you have kindly bestowed upon us as a people. For what people on the face of the earth have been so richly blessed and benefitted as we in this great State of Texas? From the days which this land was little more than trackless and wild, fit only for incautious dreamers and the most foolhardy pioneers, to this day when we are now regarded by many as a crossroad of culture and commerce and one of the most desired places to live and work and carry out our affairs as a strong and goodly people.

We are a people richly blessed with natural wealth and the capacity to develop it and to transform it into useful things, for ourselves and for others, for a better way of life. We are a people acquainted with political justice and with good laws, not experienced in other parts of the world, a very great benefit indeed. We are a people enjoying freedom to a degree unheard of in most parts of the earth, religious and economic and social and civil. We are a people of wisdom and vision, uncommonly possessed and absolutely necessary for a practical people who are committed to doing great and goodly things for the betterment of ourselves and all mankind. And these things, and so much more, we did not create ourselves, but they are all gifts of a great and goodly creator, whom we know to be our constant friend, protector, and benefactor.

And we are mindful on this day, that to whom much is given, much is also expected, for every blessing comes with a charge, a duty, a stewardship. Of all peoples, we in Texas, surely no better and no worse than other men, are most thankful for your many benefactions, and we are equally mindful of our high responsibilities. We are charged with a high sense of political purpose: to do the people's political affairs with wisdom and virtue; to protect and secure the people's dearest interests; to carry out heaven's justice on earth in this place; and to conceive wise laws which increase the common good, make safe the people's property, and make possible their pursuit of happiness.

To do these things, it is necessary that concepts be clear and unintended consequences be introduced and debated, that language be simple and unambiguous, lest the people's rights and liberties be diminished or destroyed in the balancing of interests. For this legislative assembly has no other interest or purpose but to act on behalf of the whole people, to translate their will into just laws, to think of no other business but that which secures them in their rights and their right to property, and which enlarges their liberty for self government.

Grant then, O Lord, this day, that the members of this legislative chamber, each one chosen by their constituents to represent their common interests of safety and happiness, that special wisdom which comes from above but which is readily available to every man who seeks it diligently. Grant to these worthy men and women that special virtue which rises above self-interest, and which ignores the unjust enrichment of serving political factions and commercial ambitions if they are inimical to the dearest interests of the whole people. Grant to this great house of the people that special capacity to restrain power from dangerous applications and unwarranted executions. Let the laws and the deliberations which proceed in connection with those laws be fair and equal. For this is the branch which is closest to the people, and this is the chamber which holds the greatest hope of furthering their political concerns on a practical basis. Lord, you have placed all political sovereignty in the aggregated people of this state. Grant, then, to this great chamber, the necessary wisdom, virtue, and capacity this day to do the people's justice and bring greater glory to this favored state.

Truly it can be said today, O Lord, that the peoples and nations of the world watch America to see which way it will go in this often chaotic and always challenging community of nations, and America increasingly looks to Texas for leadership and vision. Texas sends many of its brightest stars and most trusted citizens to sit in this hallowed chamber in Austin, to deliberate and to enact those things which lead to our political, social, economic, and religious prosperity.

We ask these things in the fullest confidence, without any doubt that much good will come, that what transpires in this house today, in and through all its committees and caucuses and in the whole body of this chamber, will have a permanent and lasting benefit for Texas, and for our nation, and for the good of all mankind. Amen.
