For meritorious achievement in connection with combat operations involving conflict with an opposing force while serving as Detachment Commander, Detachment 4 and Officer in Charge of the Governance Support Team, 3rd Civil Affairs Group, 1st Marine Expeditionary Force Forward, from January 2006 to August 2006 in support of Operation IRAQI FREEDOM. During this period Colonel Corte served with distinction and his accomplishments as advisor and mentor to the governor of the largest and most volatile province in Iraq were noteworthy.

His vigilant oversight and exhaustive participation in the Provincial Reconstruction Development Committee process was vital to the continuation of reconstruction projects valued at \$23 million, and the detailed planning and approval of 93 additional reconstruction projects valued at \$75 million. His efforts had a vital impact on the welfare of over a million people in Al Anbar. Colonel Corte's acumen for building capacity in governance and economics were notably evident as he led and mentored his Governance Team Leaders into a cohesive relationship with their director general of the various essential services and infrastructure. Even as murder and intimidation gripped the provincial government and placed deep fear into the populace, Colonel Corte continued steadfast to build capacity in governance.

Colonel Corte's indomitable spirit and infectious leadership was a strong source of encouragement and inspired the governor, the provincial council, and directors general of Al Anbar to continue in the fight for a free and democratic province. Colonel Corte's total effectiveness, forceful leadership, and loyal devotion to duty reflected great credit upon him and upheld the highest traditions of the Marine Corps and the United States Naval Service.
