Amendment No. 1

- (1) On page 1, lines 8-9, strike "acquire title to real property under this section" and substitute "acquire title under this section to real property, other than real property that is less than one acre or that is adjacent to real property the district already owns,".
 - (2) On page 1, line 24, strike "performed" and substitute "approved".
 - (3) On page 2, line 1, strike "or".
 - (4) On page 2, strike lines $4-\overline{6}$ and substitute the following:
- (1) an analysis of the specific site the school district intends to acquire and a comparative analysis of at least two suitable sites in the geographic area in which the school district intends to acquire real property, except that the study may include a comparative analysis of a single available site if the district shows that the site is the only suitable site in the geographic area in which the school district intends to acquire real property;
 - (5) On page 2, line 10, strike "third" and substitute "10th".
 - (6) On page 3, line 17, strike "third" and substitute "10th".

Amendment No. 1 was adopted.

Amendment No. 2

Representative Gallego offered the following amendment to **HB 1387**:

Amend **HB 1387** on page 1, line 11, after the period by inserting the following:

"The cost of a study required by this subsection shall be paid for by funds appropriated to the agency for that purpose. If the agency does not have sufficient funds available for purposes of this subsection, a school district is not required to provide for the study."

- (C) any public hearing to be held concerning an application or preapplication described by Paragraph (A); and
 - (2) respond to a subscriber via electronic mail not later than the later of:
- (A) the third business day after the date the department receives notice of an event described by Subdivision (1); or
- (B) if applicable, the date or dates specified by Section 2306.6717(a).
- (c) The department may include in an electronic mail notification sent to a subscriber any applicable information described by Section 2306.6717.

CSHB 815 - REMARKS

REPRESENTATIVE C. HOWARD: You know, it's amazing to me, it's amazing to me that this bill could be called an economic development bill. In the whole State of Texas, according to the research that we have here, there would be \$55,000 of income for the counties and the cities over that period. How much money are these same cities and counties going to have to spend for extra EMS, extra police, extra DPS? This bill, you know, it says these are for hotel guests and we just had an amendment that was accepted that said we're going to call a cab for the people that are drinking in the hotel. Why are we calling a cab for someone who had the hotel room? I mean, I'm a little bit confused. This bill does not say where this alcohol can be served. It says the hotel bar. That could be the pool deck, it could be the patio, it could be the balcony, it could even be a sports bar. So we could have drinking going on all over this hotel.

You know, we have, we've had certain communities that had the ability to extend their drinking laws from 1 a.m. to 2 a.m. on Sunday morning. And some communities enforce that, and said, "We want to extend the drinking hours." What this bill would do is say, "Well, we're wiping that out for everybody that did not want to extend that drinking law." This says, "Oh, it's 24 hours, whether you wanted extended drinking laws or not."

You are now—this is statewide. This is not one community, this is not for Houston, Texas. Let me tell you, Houston, Texas is a very favorable convention site already. We have a lot of conventions, and maybe Mr. Dutton has heard complaints about not being able to buy liquor after 2 a.m. And I will admit to you that I'm not normally up at 2 a.m., so I don't hear those complaints. But we are not in a situation where we're having to vie with someone else who provides alcohol 24 hours a day to get additional convention business.

So, I would like for y'all to seriously think about what this bill really does. It allows people to drink 24 hours a day and get on our highways and go out there on Sunday morning when most of us are going to church. These people can be coming out of the hotel bar, drunk as a coot, killing us and our kids. This is a bad bill. I hope y'all will seriously think about this, because this is a serious subject. There is no way that this can be considered an economic development bill. It is nothing other than a drink-all-night bill. The other thing I think you have to think about, and we kid about it a lot, some of these hotels, they say hotel guests, we have hotels that rent a room by the hour. So that means you can go in, rent a room for an hour and get drunk. I don't know. I ask you to think about this seriously. This is a serious matter, and I hope you'll consider it that, and I hope you will vote against this bill, because we don't need a bed and booze bill in Texas. Thank you.
