## PROCLAMATION BY THE SPEAKER APPOINTMENT OF SELECT COMMITTEE ON FEDERAL ECONOMIC STABILIZATION FUNDING

Because of the current economic situation and its effect on state revenues needed to fund essential state services, pursuant to Rule 1, Section 16 of the House Rules, I, Joe Straus, speaker of the house, create the House Select Committee on Federal Economic Stabilization Funding.

The committee shall monitor actions of the federal government, including legislation and regulations, related to efforts to promote economic recovery by providing federal funds to the states. Specifically, the committee shall examine federal funding made available to the state in the areas of transportation, health care, and education and communicate with federal officials to determine appropriate state legislation needed to maximize the state's receipt of federal funds. Further, the committee shall investigate the efforts undertaken by other states to obtain federal funding in these areas.

Consistent with the jurisdiction of the House Committee on Appropriations in Rule 3, Section 2 of the House Rules, the select committee shall make recommendations to any standing committee of the house regarding legislation necessary for the state to receive federal funds for economic recovery.

The committee shall have nine members. The following members are hereby appointed to the Select Committee on Federal Economic Stabilization Funding: Dunnam, chair; Crownover, vice-chair; Coleman, Darby, Eiland, Kent, Ortiz, Pitts, and Truitt.

**HJR 11** (By Leibowitz), Proposing a constitutional amendment increasing the amount of the residence homestead exemption from ad valorem taxation for public school purposes to \$45,000 and providing for a reduction of the limitation on the total amount of taxes that may be imposed for those purposes on the homesteads of the elderly or disabled to reflect the increased exemption amount.

**HJR 12** (By Leibowitz), Proposing a constitutional amendment to authorize the legislature to limit the maximum appraised value of a residence homestead for ad valorem tax purposes to 105 percent or more of the appraised value of the property for the preceding tax year.

**HJR 19** (By Strama), Proposing a constitutional amendment establishing the Texas Redistricting Commission to establish legislative and congressional districts and revising constitutional redistricting procedures.

**HJR 21** (By Callegari), Proposing a constitutional amendment to authorize the legislature to set a lower limit on the maximum appraised value of a residence homestead for ad valorem taxation.

HJR 22 (By Villarreal), Proposing a constitutional amendment authorizing the legislature to provide for the ad valorem taxation of a residence homestead solely on the basis of the property's value as a residence homestead; and authorizing the legislature to provide that ad valorem tax appraisal services in any county are under the jurisdiction of the entity specified by the legislature, to provide for the consolidation of ad valorem tax appraisal services, and to provide for enforcement of ad valorem tax standards and procedures by the specified entity.

To Ways and Means.

**HJR 36** (By Otto), Proposing a constitutional amendment authorizing the legislature to provide for the ad valorem taxation of a residence homestead solely on the basis of the property's value as a residence homestead; and authorizing the legislature to authorize a single board of equalization for two or more adjoining appraisal entities that elect to provide for consolidated equalizations.
