- **HB 1683** (by Cook), A bill to be entitled An Act relating to the election, and validation of acts, of members of the board of directors of Anderson County Underground Water Conservation District.
- **HB** 1758 (by Thompson), A bill to be entitled An Act relating to the requirements for a plumber's apprentice to obtain a plumber's license.

Amendment No. 1 (Committee Amendment No. 1)

Amend HB 1758 as follows:

On page 1, line 21 substitute "500" for "1,000".

Amendment No. 1 was adopted.

- **HB 1871** (by W. Smith), A bill to be entitled An Act relating to the use of Texas Department of Transportation facilities or property to serve a project aiding security in a ship channel security district.
- **HB 1963** (by Kuempel), A bill to be entitled An Act relating to eliminating the limitation on lottery advertising expenses based on the lottery prize payout percentage. (Harper-Brown, P. King, Leibowitz, Riddle, and Taylor recorded voting no.)
- **HB 1975** (by Hancock), A bill to be entitled An Act relating to refund of excess unearned premiums by insurance premium finance companies.
- **HB 2208** (by Gonzales), A bill to be entitled An Act relating to the calculation of current market value of certain water rights by the Rio Grande Regional Water Authority.

HB 2237 (by Hamilton), A bill to be entitled An Act relating to possession by certain alcoholic beverage permit holders of certain alcoholic beverages for cooking purposes.

CSHB 2275 (by Raymond, Guillen, Flynn, Shelton, and Martinez), A bill to be entitled An Act relating to creating a task force to develop uniform standards for subdivisions in the unincorporated areas of counties near the international border and in economically distressed counties.

HB 2433 (by W. Smith), A bill to be entitled An Act relating to the powers of certain freight rail districts.

- **HB 2434** (by W. Smith), A bill to be entitled An Act relating to the supervision by the Texas Department of Transportation of money appropriated by the federal government for the construction and maintenance of rail facilities.
- **HB 2560** (by Kuempel), A bill to be entitled An Act relating to delinquent payment of an alcoholic beverage retailer's account for liquor.

SB 538 Estes

Relating to the amount of wine certain wineries may sell directly to consumers.

SB 540 Estes

Relating to notice of an application for a permit to dispose of oil and gas waste in a disposal well.

SB 899 Deuell

Relating to the participation in state travel service contracts by certain local governmental entities.
