regulations; design of building drain and waste system plumbing, fresh water plumbing, grey water systems and mechanical aspects of moving water in and out of a structure; evaluation of structural framing members prior to the addition of roof-mounted equipment or heavier roof covering; design of changes in roof pitch by the addition of structural framing members; evaluation and repair of damaged roof structural framing; electrical power and signal systems; shop drawings by manufacturers or fabricators of materials and products to be used in the building components designed by the engineer; and specifications listing the nature and quality of materials and products for construction of elements of the building designed by an engineer?

Representative Hardcastle, is it also your understanding that there is still some work to be done on this compromise but we are willing to work on that in the senate?

REPRESENTATIVE HARDCASTLE: This in no way will change the ability of an architect and how they can practice. And, yes, there are several things that need to be worked on in the senate, and we'll have it back.

- [(1) is an heir of the decedent, if the results of genetic testing ordered under Subchapter B identify a tested individual who is an heir of the decedent as the ancestor of the individual described by Section 204.151; or
- [(2) is not an heir of the decedent, if the results of genetic testing ordered under Subchapter B exclude a tested individual who is an heir of the decedent as the ancestor of the individual described by Section 204.151.]
- (5) On page 19, line 6, strike "49(a), 77," and substitute "49(a), 53C(a) and (b), 77,".

Amendment No. 1 was adopted.
