## MAJOR STATE CALENDAR SENATE BILLS SECOND READING

# SB 23 ON SECOND READING (Kolkhorst, Moody, Carter, and P. King - House Sponsors)

**SB 23**, A bill to be entitled An Act relating to the punishment for a capital felony committed by an individual younger than 18 years of age.

(Gooden in the chair)

#### Amendment No. 1

Representatives Schaefer, Carter, Hughes, Moody, and Toth offered the following amendment to  ${\bf SB~23}$ :

Amend **SB 23** (house committee report) as follows:

- (1) On page 1, strike lines 13-18 and substitute the following: "imprisonment in the Texas Department of Criminal Justice [for]:
- (1) for life, if the individual committed the offense when younger than 17 years of age [individual's ease was transferred to the court under Section 54.02, Family Code];
- (2) for life or for life without parole, if the individual committed the offense when 17 years of age; or
- (3) for (2) life without parole, if the individual committed the offense when 18 years of age or older."
  - (2) On page 2, strike lines 4-5 and substitute the following:
- "offense when younger than 17 years of age [ease was transferred to the court under Section 54.02, Family Code];

- (2) a sentence of either life imprisonment or life imprisonment without parole is mandatory on conviction of the capitol felony, if the individual committed the offense when 17 years of age; or"
  - (3) On page 2, line 6, strike "(2)" and substitute "(3) [(2)]".
- (4) Strike SECTION 2 of the bill (page 2, lines 9-15), substitute the following appropriately numbered SECTIONS, and renumber subsequent SECTIONS of the bill accordingly.:

SECTION \_\_\_\_\_. Section 1, Article 37.071, Code of Criminal Procedure, is amended to read as follows:

- Sec. 1. (a) If a defendant is found guilty in a capital felony case in which the state does not seek the death penalty, the [judge shall sentence the] defendant shall be sentenced to imprisonment for life or for life [imprisonment] without parole as described by this section and by Section 12.31, Penal Code.
- (b) The judge shall impose a sentence of imprisonment in the Texas Department of Criminal Justice for life without parole with respect to a defendant who was 18 years of age or older at the time the capital felony was committed.
- (c) The judge shall impose a sentence of imprisonment in the Texas Department of Criminal Justice for life with respect to a defendant who was younger than 17 years of age at the time the capital felony was committed.
- (d)(1) The judge or jury shall impose a sentence of imprisonment in the Texas Department of Criminal Justice for life or for life without parole with respect to a defendant who was 17 years of age at the time the capital felony was committed.
- (2) In determining the appropriate sentence under this subsection, the court shall consider any mitigating factors that may have contributed to the commission of the offense.
- (3) If the punishment is to be assessed by the jury rather than the judge, the judge shall charge the jury in writing as follows:
- "Under the law applicable in this case, it is possible that any sentence of life imprisonment might be reduced by the award of parole. However, the defendant will not become eligible for parole until the actual time served equals 40 years, without consideration of good conduct time, and the eligibility for parole does not guarantee that parole will be granted.
- "It cannot accurately be predicted how the parole law might be applied to this defendant if the defendant is sentenced to life imprisonment, because the application of these laws will depend on decisions made by prison and parole authorities.
- "You may consider the existence of the parole law. However, you are not to consider the manner in which the parole law may be applied to this particular defendant."
- (4) Subdivision (3) does not permit the introduction of evidence on the operation of parole laws.
- SECTION \_\_\_\_\_. Section 508.145(b), Government Code, is amended to read as follows:
- (b) An inmate serving a life sentence under Section 12.31(a)(1) or (2), Penal Code, for a capital felony is not eligible for release on parole until the actual calendar time the inmate has served, without consideration of good conduct time, equals 40 calendar years.

#### Amendment No. 2

Representative Moody offered the following amendment to Amendment No. 1:

Amend Amendment No. 1 by Schaefer to **SB 23** as follows:

(1) On page 1, line 18, strike "capitol felony" and substitute "capital felony".

(2) On page 2, immediately following the underlined period at the end of line 15, insert the following:

Notwithstanding the exception language provided by Section 2(b), Article 37.07, the determination of who will assess punishment under this subsection is governed by Section 2(b), Article 37.07.

(3) On page 2, strike lines 16-18 and substitute the following:

(2) Evidence may be offered by the state and the defendant as to any matter that the court considers relevant to the sentence, as governed by Section 3, Article 37.07, including evidence of the defendant's background or character and evidence of the circumstances of the offense. In determining the appropriate sentence, the judge or jury shall consider any relevant mitigating evidence, including the defendant's age.

(4) On page 2, strike lines 22 and 23 and substitute the following:

"Under the law applicable in this case, a defendant sentenced to imprisonment for life without parole is ineligible for release on parole from the Texas Department of Criminal Justice.

"It is possible that any other sentence of imprisonment for life might be reduced by the

(5) On page 2, line 31, strike "these laws" and substitute "this law".

Amendment No. 2 was adopted.

#### Amendment No. 1 - Point of Order

Representative Dutton raised a point of order against further consideration of Amendment No. 1 under Article III, Section 40 of the Texas Constitution on the grounds that the subject is not designated in the proclamation by the governor.

The chair overruled the point of order and submitted the following statement:

Representative Dutton raised a point of order against further consideration of Amendment No. 1, as amended by Amendment No. 2, to **SB 23** asserting that it violates Article III, Section 40 of the Texas Constitution because it is outside the scope of the governor's call. The point of order is respectfully overruled.

The call adds "legislation relating to establishing a mandatory sentence of life with parole for a capital felony committed by a 17-year-old offender." Currently, Texas law provides that 17-year-olds who commit a capital felony may be sentenced to the death penalty or to life without parole. **SB 23** provides that 17-year-olds who commit a capital felony will receive a sentence of life with the possibility of parole. The amendment at issue retains the existing sentence of life without parole as an option for punishing these offenders in addition to **SB 23**'s new option of life with parole. Because the amendment relates to establishing a mandatory sentence of life without parole for 17-year-olds who commit a capital felony, it does not violate Article III, Section 40 of the Texas Constitution. See pages 146-149 of the House Rules containing explanatory notes and house precedents regarding legislation that may be considered in a special session.

#### Amendment No. 3

Representative Dutton offered the following amendment to SB 23:

Amend SB 23 (house committee report) as follows:

(1) Add the following appropriately numbered SECTION to the bill and renumber subsequent SECTIONS of the bill accordingly:

SECTION \_\_\_\_\_. Section 7.02, Penal Code, is amended by amending Subsection (b) and adding Subsection (c) to read as follows:

- (b) Except as provided by Subsection (c), if [H;] in the attempt to carry out a conspiracy to commit one felony[,] another felony is committed by one of the conspirators, all conspirators are guilty of the felony actually committed, though having no intent to commit it, provided that [if] the offense was committed in furtherance of the unlawful purpose and was one that should have been anticipated as a result of the carrying out of the conspiracy.
- (c) Notwithstanding any other law, an individual may not be charged with a capital felony under Subsection (b) if the individual is younger than 18 years of age at the time the capital felony is committed by one of the conspirators.
- (2) On page 2, line 16, strike "The change" and substitute "(a) Except as provided by Subsection (b) of this section, the change".
  - (3) On page 2, between lines 22 and 23, insert the following:
- (b) The change in law made by this Act in amending Section 7.02, Penal Code, applies only to an offense committed on or after the effective date of this Act. An offense committed before the effective date of this Act is covered by the law in effect when the offense was committed, and the former law is continued in effect for that purpose. For purposes of this subsection, an offense was committed before the effective date of this Act if any element of the offense occurred before that date.

## Amendment No. 3 - Point of Order

Representative Moody raised a point of order against further consideration of Amendment No. 3 under Rule 11, Section 2 of the House Rules on the grounds that the amendment is not germane to the bill.

The chair overruled the point of order and submitted the following statement:

Representative Moody raised a point of order against further consideration of Amendment No. 3 to **SB 23** under Rule 11, Section 2 of the House Rules. The point of order is respectfully overruled.

SB 23 provided for the option of a sentence of life with parole for offenders under the age of 18 who are convicted of a capital felony. Amendment No. 3 would have made SB 23's sentencing provisions inapplicable to certain persons under 18 by prohibiting them from being charged with a capital felony if the

capital felony in question was committed by a conspirator. Because the amendment relates to the punishments applicable to juveniles who commit a capital felony, it was germane to **SB 23**.

Representative Kolkhorst moved to table Amendment No. 3.

The motion to table prevailed.

Plan No. H354

Amend **SB 3** on third reading by striking the changes made by Floor Amendment No. 7 by Giddings (PLANH341) to SECTIONS 109, 111, and 113 of ARTICLE II, as added by Floor Amendment No. 1 by Darby, and by striking SECTION 110 of ARTICLE II of Floor Amendment No. 1 by Darby (PLANH309), and substituting the following:

SECTION 109. REPRESENTATIVE WU: Members, I'm going to keep this very short. I have an amendment that I will withdraw at the end of this. My amendment is to take one precinct and swap it—and take it—it is not a swap—it's taking one precinct, Precinct 311, and putting it into my district. The reason for this is this is a precinct that is a part of a very large community in our area, the Sharpstown community, the namesake of the Sharpstown scandal. This community has been together under one district since its creation—has never been separated. During the 2011 redistricting, this precinct was cut apart and shoved into Representative Miles' district. Our local constituents were very upset about this, they felt very disenfranchised. The San Antonio court actually put this precinct back together with this district, but it was then subsequently taken out during the interim for the

interim map. We don't know why. I have letters from the civic associations stating, asking us, pleading to be put back together so that their political voice actually means something again.

Representative Scott Hochberg testified in committee and I'll—just for the record, I would like to very briefly read in what he testified to. This is his written statement talking about this district being—this precinct being cut out. One possible justification would be that, if the district was somehow reconfigured to unify a community of interest, but the opposite is true. The core of District 137 is Sharpstown. Sharpstown is a residential community of almost 7,000 single family homes, all built by the same developer. In the new maps, two of these precincts, 311 and 427, have been removed and placed into a district currently represented by Representative Miles. I'm going to skip a little bit. Both of these districts work together on legislative issues including crime, gang control, and transportation, beautification, and business development. There is no need or reason to split this community.

Later on, Mr. Hochberg—Representative Hochberg, your colleague, also testified in court providing his written, sworn statement that at the time this change was made, it reduces a minority concentration in District 137, his district at the time, so that an Anglo democrat has a better opportunity to secure elections. Members, the removal of this precinct was very upsetting to our community. It tore our community apart. I still have members come up to me and ask why I don't represent them on nearly—probably a monthly basis. When they see me at local events, at the Sharpstown Civic Association's meeting they go, "Oh, can you help me with this?" and I say, "Absolutely, but I want you to know you're no longer in my district." And people are very upset about this. Because I am unable to secure the political support to do this—make this change—I will now withdraw my amendment.

Amendment No. 2 was withdrawn.

DARBY: Members—Jonathan—do you want to ask some questions?

REPRESENTATIVE STICKLAND: Mr. Darby, we adopted an amendment yesterday that affected Representative Ratliff and Representative Anchia's district, correct?

DARBY: Correct.

STICKLAND: And those districts are House District 103 and 115?

DARBY: Correct.

STICKLAND: That amendment was quickly discussed and you accepted that yesterday, correct?

DARBY: Correct.

STICKLAND: Who first presented that amendment to you?

DARBY: Representative Anchia did. STICKLAND: Representative who?

DARBY: Anchia.

STICKLAND: And when was that?

DARBY: I can't recall.

STICKLAND: Is Representative Anchia here today?

DARBY: I don't see him here.

STICKLAND: Okay. Was this more than a week ago that he brought you this amendment?

DARBY: I can't recall when they filed in DistrictViewer. It was relatively close to the end of the week.

STICKLAND: The end of last week?

DARBY: Last week. Or the first of this week. I can't remember.

STICKLAND: Was that amendment discussed in the Select Redistricting Committee?

DARBY: It was not.

STICKLAND: Was it brought up at any of the field hearings?

DARBY: Not that I recall.

STICKLAND: Was that amendment presented to us as an amendment to unite a community of interest in Farmers Branch?

DARBY: That was my understanding.

STICKLAND: It put a portion of Farmers Branch that was in Representative Ratliff's district into Representative Anchia's district, correct?

DARBY: I believe that was the effect.

STICKLAND: And it put a portion of Coppell into Representative Anchia's district into Representative Ratliff's district, correct?

DARBY: I think so. I'm not familiar with the precincts and where they are on the ground, but that's my understanding.

STICKLAND: And that's what we discussed yesterday, correct?

DARBY: Correct.

STICKLAND: But that amendment didn't just move those parts of those two cities. It also removed a portion of Irving from Representative Ratliff's district and it put into Representative Anchia's district. Were you aware of that?

DARBY: I've recognized that it took precincts out of Representative Anchia's district and put precincts into Representative Ratliff's district and vice versa.

STICKLAND: Did we discuss the city of Irving when that amendment was represented to this body?

DARBY: I did not, nor did I know, that if affected the city of Irving.

STICKLAND: Are you aware of the newspaper the Austin American-Statesman?

DARBY: Yes, Jonathan, I'm aware of the Austin American-Statesman.

STICKLAND: Were you aware that they reported that a rumored candidate running against Representative Ratliff named Matt Rinaldi?

DARBY: I tried not to listen to all these rumors.

STICKLAND: Are you aware that Matt Rinaldi ran against Bennett Ratliff in the last primary?

DARBY: Where are you going with this, Representative Stickland?

STICKLAND: I get to ask the questions, Mr. Darby. Are you aware—

DARBY: I can ask—knock yourself out, Jonathan. Knock yourself out. Just ask all you want.

STICKLAND: Are you aware that Matt Rinaldi ran against Representative Ratliff in the last republican primary?

DARBY: If you say he did, he did, Jonathan.

STICKLAND: And are you aware that that specific thing that was not discussed, was not vetted, or submitted at the field hearing, cut that gentleman out of his district yesterday?

DARBY: I'm not aware of that, Jonathan.

STICKLAND: When that amendment was presented to you, was it presented as an amendment to cut out a specific potential candidate?

DARBY: It was presented to me as an amendment to fix the deviation issues with both districts.

STICKLAND: You were not aware that there might be any political motivations behind yesterday's—

DARBY: I was not aware of any political motivations, Jonathan.

STICKLAND: I was under the mistaken understanding that we weren't going to make any changes to the map. Were you under that as well?

DARBY: I was never under that understanding, Jonathan. I had a role to fill and a duty on behalf of this house to look at these maps to see what was legally required under the constitution and under the Voting Rights Act, and to do my duty on behalf of the this house in order to make sure we have maps that are compliant with the constitution and with the legislative intent of this body.

STICKLAND: So it's your understanding nothing was politically motivated yesterday?

DARBY: We don't do anything here without some politics involved, Jonathan, but I'm saying the motivation behind this amendment was to end the deviation disparities in those two districts.

STICKLAND: All right.

REPRESENTATIVE PHILLIPS: Representative Darby, I want to go back and visit that little conversation soliloquy you had with Mr. Stickland. Let me ask you, are you aware—he's concerned about one amendment that was brought up, is that correct?

DARBY: That's my understanding.

PHILLIPS: Okay, and I don't know all the details, but it's an amendment that was brought up and it was submitted, and you stood up front—the amendment was brought by somebody on behalf of Mr. Anchia—

DARBY: Jason Villalba.

PHILLIPS: Mr. Villalba brought the amendment and he stood up there and said, I have an amendment on behalf of Anchia, and you described how it traded between two districts, is that correct?

DARBY: That's correct.

PHILLIPS: And so, this was all done on the floor, with the lights on, with us all knowing what's going on. Is that correct?

DARBY: I hope so.

PHILLIPS: In the DistrictViewer and so anybody that had a question about that could pay attention. Now, let me ask you this, now that amendment wasn't just brought up real quick and filed two minutes before you did that was it?

DARBY: It's my understanding that amendment was on DistrictViewer for several days.

PHILLIPS: Right, so anybody could have had an issue, so if somebody's upset like something happened without them being able to be aware of it, they were not paying attention and they were not doing their job.
