PROCLAMATION BY THE SPEAKER SELECT COMMITTEE ON CRIMINAL PROCEDURE REFORM APPOINTED

The speaker laid before the house and had read the following proclamation:

Pursuant to Rule 1, Section 16 of the House Rules, I, Joe Straus, speaker of the Texas House of Representatives, create the House Select Committee on Criminal Procedure Reform.

The Code of Criminal Procedure governs the treatment of every person and entity involved in a criminal proceeding in Texas. It safeguards the rights of the accused and our state. The code provides mechanisms not only for prosecution but also for prevention of crimes against our citizens. This vital statute has not been rewritten since 1965. As a result, it has become overcrowded, disorganized, and difficult to navigate, such that there is a pressing need to consider rewriting and reorganizing it. Therefore, this select committee shall study and make recommendations regarding the reorganization and revision of the Code of Criminal Procedure.

The committee may use the resources of or request assistance from any state agency, including the Texas Legislative Council and the Office of the Attorney General.

The committee shall have five members. The following members are hereby appointed to the House Select Committee on Criminal Procedure Reform: Riddle, chair; Carter, Herrero, Moody, and Parker.

PROCLAMATION BY THE SPEAKER SELECT COMMITTEE ON TRANSPARENCY IN STATE AGENCY OPERATIONS APPOINTED

The speaker laid before the house and had read the following proclamation:

Pursuant to Rule 1, Section 16 of the House Rules, I, Joe Straus, speaker of the Texas House of Representatives, create the House Select Committee on Transparency in State Agency Operations.

While for a number of years the legislature has had a General Investigating and Ethics Committee to investigate and examine legislative issues, we have never had a single investigative committee focused on other branches of government. In recognition of the fact that it is in the best interest of Texans to remain engaged and informed about the operations of all branches of government, and to encourage greater transparency in the expenditure of state funds, this committee shall oversee transparency in the reporting of financial transactions of judicial and executive state agencies and affiliated entities. This oversight shall include monitoring the operations of executive and judicial state agencies as well as affiliated agencies, entities, foundations, and related support groups.

Further, the committee shall monitor the hiring and compensation practices of judicial and executive state agencies, including any affiliated entities, whether public or private. It shall also oversee the purchasing decisions made by judicial and executive state agencies and affiliated entities.

This committee may request the assistance of other committees in obtaining information.

The committee shall have eight members. The following members are hereby appointed to the House Select Committee on Transparency in State Agency Operations: Alvarado, co-chair; Flynn, co-chair; N. Gonzalez, Johnson, Larson, Martinez Fischer, Perry, and Price.
