INTRODUCTION OF GUESTS

The chair recognized Representative S. Turner who introduced a delegation commemorating the 50th anniversary of the Supreme Court decision in *Gideon v. Wainwright*, speaking as follows:

Today, the Texas Indigent Defense Commission hosted a commemoration of the 50th anniversary of *Gideon v. Wainwright*, the landmark Supreme Court decision requiring states to provide counsel to those too poor to hire counsel. Participants for the commemoration include the following, and they are up on the dais now. One is Bruce Jacob, former assistant attorney general of Florida, who argued *Gideon v. Wainwright* before the U.S. Supreme Court; two, the Honorable Sharon Keller, the presiding judge of the Texas Court of Criminal Appeals; three, Buck Files, president of the State Bar of Texas; four, Lydia Clay-Jackson, president of the Texas Criminal Defense Lawyers Association.

Some of the following individuals that are on the dais have been exonerated here in Texas, and I want to introduce some of them to you as well. Johnnie Lindsey, who was incarcerated 27 years before being found innocent for a crime that he did not commit. Charles Chatman, who served 26 and a half years in prison before being found innocent for a crime that he did not commit. Claude Simmons served 12 years in prison before being found innocent for a crime that

he did not commit. Johnny Pinchback served 26 and a half years in prison before being found innocent for a crime that he did not commit, and David Wiggins, who served 23 years in prison before being found innocent for a crime that he did not commit. Also, Ruby Cole Session is standing on behalf of Tim Cole, who served 13 years in prison before being found innocent for a crime that he did not commit. In honor and commemoration of *Gideon v. Wainwright*, Mr. Speaker and members, I put forth **HR 808** and move its adoption.
