## PARLIAMENTARY INQUIRY

REPRESENTATIVE HERRERO: What is the impact of a statement between members on the floor with respect to precedent?

CHAIR (Springer in the chair): Mr. Herrero, we'd have to look at what the discussion was and when it occurred.

HERRERO: Specifically, the discussion between members on the floor that, despite the fact that we are now imposing a calendar rule on bills that traditionally have not had rules other than—that would have been applied, the rule that we adopted today, the calendar rule—that that somehow doesn't establish precedent.

CHAIR: Mr. Herrero, that is a conversation between the two participants here and reflected the views of the two participants, and we will put that into the journal if you would like.

## **REMARKS ORDERED PRINTED**

Representative Herrero moved to print remarks between the chair and Representative Herrero.

The motion prevailed.

# AMENDMENT CONSIDERATION RULE REMARKS

HERRERO: On that note as well, the fact that this is merely a conversation, would it not be true then that if people were to look at these votes and determine how and when the rule has been applied, that you would then consider these votes we've taken both yesterday on **HB 5** and today on **HB 4**?

CHAIR: I think they're nothing more than the vote on Calendars for **HB 4** and **HB 5**.

HERRERO: I didn't understand your response, Mr. Speaker.

CHAIR: All that reflected in the dialogue was those two bills.

HERRERO: Right, and I guess what I'm trying to figure out is, all of a sudden, at least in my opinion, it appears that we're adopting the calendar rule on bills that have traditionally have not been applied the calendar rule. And what's going to be the basis moving forward on what constitutes a calendar rule and what doesn't? If it's already written in the rules how we're going to apply the calendar rule?

CHAIR: Thank you, that's something for us to certainly consider.

HERRERO: Please, Mr. Speaker, the other thing I wish that you would consider is the fact that I, as a member, because I am not on Calendars, I do not know that this is going to be part of the floor vote until I see it happening or until the motion is made. What kind of notice do we as members have that a proposed calendar rule is going to be put on things that, under the rules that we've adopted, shouldn't have a calendar rule?

CHAIR: Calendar rules are printed on the back of calendars as they're adopted, and they're printed and distributed after the calendar is adopted.

HERRERO: So is it printed in today's calendar that we're going to adopt the calendar rule on **HB 4**?

CHAIR: The calendar rules are printed on the calendar which set **HB 4**, which was printed and distributed yesterday.

HERRERO: On the HRO, then, where would I find this? Is it on the HRO? On yesterday's HRO?

CHAIR: Mr. Herrero, the calendar which both set **HB 4** and set the calendar rule for **HB 4** was printed and distributed to each office yesterday.

HERRERO: By what means?

CHAIR: It was electronically distributed to all offices like we distribute all single calendars, and it was also published to both the TLIS and TLO websites.

HERRERO: Is it going to be the practice of this house in this session to adopt a calendar rule on bills that, traditionally, under the rules that we've adopted, would not have a calendar rule?

CHAIR: We direct you to the chairman of the Calendars Committee for what the Calendar Committee is going to do.

HERRERO: Chairman Hunter, I'm just trying to figure out why we are adopting a calendar rule that traditionally hasn't had been applied, if you will, to bills other than Sunset bills and budgets.

REPRESENTATIVE HUNTER: The Calendars Committee has discretion, Representative Herrero. We made a decision on **HB 4** and **HB 5**, we generally are, correct Sunset bills, appropriations bills, emergency items sometimes. Right now, the only bills that we've considered a calendar rule was **HB 4** and **HB 5**, and the authors came and asked. So we felt that their wishes on the subject matter—and they thought there might be amendments that they needed to review or they thought there would be amounts—we use that discretion. Right now, I haven't been asked for any calendar rules except, I'm sure **HB 1** or **SB 1**, whichever title, will involve that, and of course the Sunset bills that come forward, but that's built in.

HERRERO: What is going to be the procedure then for me, as a member, to request from the Calendars Committee to have a calendar rule on a bill that I have before the house floor?

HUNTER: All you have to do is ask.

HERRERO: I formally now am asking, Mr. Chairman, that we adopt a calendar rule for every member's bill.

HUNTER: Well, I don't think that you can ask on behalf of everybody, Representative Herrero, but if you have a request, if you will meet with me and the committee, we'll consider it. We consider it bill by bill.

HERRERO: And what is going to be the standard or the qualification for what is or what is not one that would require a calendar rule?

HUNTER: I don't think there's any standard or qualification, we do each bill on a bill-by-bill basis.

HERRERO: It's going to be the discretion of the chair, or the discretion of the committee-

HUNTER: I think it's the decision of the committee first, and then it's the final decision of the body of the house.

HERRERO: What other bills, if any, have you been requested to adopt the calendar rule for that are outside of Sunset and budgets?

HUNTER: At this time, nobody, but you just did.

HERRERO: And would you, as a chairman, advise the body, not through a printed rule 24 hours or less than 24 hours before we're expected to vote, but as the requests come in, let us as a body know that requests have been made for calendar rules on bills?

HUNTER: I couldn't hear you, but you're saying—here's the procedure: we hold a Calendars meeting; if the author of the bill wants a Calendars rule, they raise it to me and I present it to the committee. If the Calendars rule is adopted, we bring it to the body, and two-thirds, I believe, of members present have to approve it.

HERRERO: I'm just trying to figure out how I as a member, not part of Calendars, am going to know that requests have been made, that we should even consider amendments within the 24-hour period that this rule gets adopted.

HUNTER: Here's the deal, if you would like one, come talk to me and I'll present it to the committee. That's how we do it, and then it's printed for your consideration.

HERRERO: And none of what we're doing is going to establish precedent, is that correct?

HUNTER: You know, everybody talks about precedent—I think each session is a precedent. And I think that I have told you that there's no predetermined intent to do calendar rules on every bill.

HERRERO: Right, but if two sessions from now someone were to request or propose a calendar rule outside of a Sunset bill or a budget bill, and the question's going to be, "Has this ever been done before?" And they're going to look to these two bills in particular and say, "Yes, it has, members."

HUNTER: I'm not sure I agree with that analysis, but each session is different. The body of the house and the senate are generally different. They can rely on precedent, they can rely on current times; amendments are different from one session to the other. The way I look at it, if a member comes to me, we will consider it in committee, and then we will always present it to the house—everybody has notice.

HERRERO: Well, thank you, Mr. Chairman, because part of what I think happens when we adopt calendar rules is it restricts debate, because if an issue comes up through the discussion of an amendment that was prefiled—not necessarily an amendment to the amendment—but an amendment to the body of the bill, I have no recourse or ability to address that issue in an amendment because the deadline has already passed. And so, we have a deadline before we have the actual thought that arises.

HUNTER: Well, Representative Herrero, I don't agree with you. We went through this yesterday with other members, but I'll repeat what I said—I don't believe there's any limitation of debate. All this is is an order and a process. You have a deadline to file amendments, and you've got plenty of time. This is Thursday, you have all the way until next Tuesday at 2 o'clock, and if you want to debate, you'll get those amendments in. And all this is is a process and order that by 2 o'clock next Tuesday, everybody and the public have knowledge of what amendments are there, and you have every right to debate those amendments. It's just a process.

HERRERO: Right, but if the thought comes after the deadline, tough luck.

HUNTER: I don't know what your thought would be. If the amendment comes after the deadline, then you have a deadline that you missed.

HERRERO: Mr. Chairman, the situation is this, where, especially on **HB 5**, for example, if we send information to our school districts and ask them to review it, sometimes not one individual is going to know all the ramifications of **HB 5**, and so, they take whatever time they need to take to vet or analyze, study the bill. And even if we say to them, "This is my deadline, this is what the calendar rule that was adopted says," essentially, when they come to us as constituents—because they come to us after the deadline to file amendments, and we're going to have to tell them, "I can't help you, because the floor, the legislature, the house has adopted a rule that says, because you didn't get to me before the deadline that we imposed, I can't help you on that issue."

HUNTER: Well, Representative Herrero, first, I would hope you've been researching and studying the bill so that you don't wait until the 11th hour. The second thing is, 2 o'clock next Tuesday to 10 o'clock the next day, I don't think that's a very harsh standard at all. I think that if you have discussions, concepts, talk to the chairman, let's say, of water—Chairman Ritter. You also have third reading where you can raise the issue. So I think we disagree about the debate concept, as I discussed on the microphone yesterday. I personally believe it's a practical, good process; it makes sure everybody in this house has time to read these ideas, but it doesn't stop you on third reading, and it certainly doesn't stop you from talking to the chairman of the committee.

**HB 1600**, A bill to be entitled An Act relating to the continuation and functions of the Public Utility Commission of Texas, to the transfer of certain functions from the Texas Commission on Environmental Quality to the Public Utility Commission of Texas, and to the functions of the Office of Public Utility Counsel; authorizing a fee.

SECTION 1.\_\_\_\_. Subchapter A, Chapter 52, Utilities Code, is amended by adding Section 52.008 to read as follows:

Sec. 52.008. LEGISLATIVE APPROVAL REQUIRED FOR CERTAIN COMMISSION ACTIONS. The commission may not take an action that results in an increase of surcharges on a customer's monthly bill for telecommunications products or services or causes the amount of a customer's monthly bill for telecommunications products or services to increase without legislative approval.
