HB 2472 - (consideration continued)

Amendment No. 1

Representative Cortez offered the following amendment to **HB 2472**:

Amend **HB 2472** (house committee report) by adding the following appropriately numbered SECTION to the bill and renumbering subsequent SECTIONS of the bill accordingly:

SECTION _____. Section 2054.051(f), Government Code, is amended to read as follows:

- (f) The department shall identify opportunities for state agencies to:
- (1) coordinate with each other in the adoption and implementation of information resources technology projects; and
- (2) obtain a royalty, license right, or other appropriate means of securing appropriate compensation from information resource systems developed with proprietary information.

Amendment No. 1 was withdrawn.

HB 2472 was passed to engrossment.

CSHB 424, A bill to be entitled An Act relating to the sex offender status of a person who becomes a resident of certain group home facilities.

Amendment No. 1

Representative Burkett offered the following amendment to CSHB 424:

Amend CSHB 424 (house committee printing) as follows:

(1) On page 3, between lines 8 and 9, insert the following:

Sec. 325.006. NOTICE ABOUT CURRENT RESIDENTS. Not later than March 1, 2014, the director of a group home shall ascertain, in the manner provided by Section 325.003, whether any resident of the group home is registered under Chapter 62, Code of Criminal Procedure, and provide to the legal guardian of each current resident who has a legal guardian, and directly to each other resident, notice about each resident who is required to register under that chapter as provided by Section 325.004. This section expires April 1, 2014.

(2) On page 3, strike lines 9 through 14 and renumber subsequent SECTIONS of the bill accordingly.

CSHB 424 - STATEMENT OF LEGISLATIVE INTENT

REPRESENTATIVE MOODY: There's an immunity-of-liability provision at the end of the bill, and my understanding is, if someone—a director—operates outside of your bill, so does not go through the process that you've laid out—going to the DPS website—and maybe is acting in bad faith, they don't get that same immunity, correct?

REPRESENTATIVE BURKETT: Yes, sir, that is correct. The way it's written right now does not give immunity to a bad actor who's not working within the intent of the law
