### SB 202 ON THIRD READING (Price and Guillen - House Sponsors)

SB 202, A bill to be entitled An Act relating to the continuation and functions of the Texas Commission on the Arts.

#### Amendment No. 1

Representative Price offered the following amendment to **SB 202**:

Amend **SB 202** on third reading as follows:

(1) In Subsection (c) of SECTION 5 of the bill, directing the governor to appoint members to the Texas Commission on the Arts for terms scheduled to begin September 1, 2015, immediately following the period (page 2, line 23), insert the following:

Two of the three members appointed to the commission for terms expiring August 31, 2021, must be residents of a county with a population of less than 50,000, as provided by Section 444.003, Government Code.

(2) Add the following appropriately lettered subsection to SECTION 5 of the bill and reletter subsequent subsections accordingly:

(\_\_\_\_) To the extent that the reduction in positions on the Texas Commission on the Arts under this Act causes the composition of the commission to violate the residency requirement of Section 444.003(a), Government Code, that provision of law is suspended from the effective date of this Act until September 1, 2015.

Sec. 423.002. STUDIES. (a) The office of the governor shall conduct a biennial study on driving while intoxicated in this state that monitors and analyzes:

- (1) the efficacy of restrictions on eligibility for release on parole or to mandatory supervision for persons convicted of certain intoxication offenses in deterring or preventing future intoxication offenses, including the provisions of 508.145(d)(1) and 508.149(a), Government Code, as amended by Chapter 1 (SB 24) and 122 (HB 3000), Acts of the 82nd Legislature, Regular Session
- (2) driving while intoxicated data collected in this state, including data relating to:
  - (A) driving fatalities involving intoxicated drivers;
- (B) automatic driver's license suspensions by the Department of Public Safety for convictions of an offense relating to the operating of a motor vehicle while intoxicated; and
- (C) the number of intoxication offenses resulting in a sentence of 25 years or more for an offense under Chapter 49, Penal Code
- (3) the laws and programs of other states that have been successful in reducing the occurrence of offenses relating to the operating of a motor vehicle while intoxicated, including sentencing of intoxication offenses;
- (4) the impact on public safety of repeat and habitual offenders and intoxication offenses causing serious bodily injury or death, including the sentencing of intoxication offenses; and
- (b) Based on the studies conducted under Subsection (a), the office of the governor shall collaborate with the Texas Department of Transportation, the Department of Public Safety, and the Department of State Health Services to reduce alcoholism and recidivism and the number of driving while intoxicated offenses committed in this state, including repeat and habitual offenses and offenses causing serious bodily injury or death.
- (c) Not later than January 1 of each odd-numbered year, the office of the governor shall submit a report to the legislature that:
- (1) describes the total number of sentences imposed of 25 years or more for an offense under Chapter 49, Penal Code
- (2) describes the success of state laws and programs in reducing the occurrence of offenses relating to the operating of a motor vehicle while intoxicated;
- (3) analyzes the efficacy of restrictions on eligibility for release on parole or to mandatory supervision for persons convicted of certain intoxication offenses in deterring or preventing future intoxication offenses; and
- (4) recommends legislation relating to the prevention of those offenses in this state, including repeat and habitual offenses and offenses causing serious bodily injury or death.

### **CSHB 517 - STATEMENT OF LEGISLATIVE INTENT**

REPRESENTATIVE WU: Mr. Pitts, I just want to make sure I clarify. In the bill, it says 25 years for an offense. Now, intoxication manslaughter is one of the few offenses in the state penal code that is what we call a "stackable" offense. Most of the time, when there is a crime where there are multiple charges out of that crime, the charges, if you get convicted on all of them, those sentences run concurrently.

That means they run all together at the same time. Does your bill intend to calculate the 25 years based on an offense that is stacked, or a single offense that a person receives 25 years?

REPRESENTATIVE PITTS: A singular offense.

WU: Okay, so that, if a person—if there is an intoxication manslaughter charge where, let's say, multiple people were killed, and that person received 10 years for each of those deaths, that person would not fall into this bill?

PITTS: That is right.

(d-1) Notwithstanding Subsection (a), (b), (c), or (d), if property described by Subsection (a), other than money, is seized by a peace officer at the time the owner of the property is arrested for an offense punishable as a Class C misdemeanor, the law enforcement agency may provide notice to the owner at the time the owner is taken into or released from custody. On receiving the notice, the owner must sign the notice and attach a thumbprint to the notice. The notice must include:

- (1) a description of the property being held;
- (2) the address where the property is being held; and
- (3) a statement that if the owner does not claim the property before the 31st day after the date the owner is released from custody, the property will be disposed of and the proceeds of the property, after deducting the reasonable expense of keeping and disposing of the property, will be placed in the treasury of the municipality or county providing the notice.
- (d-2) If the property for which notice is provided under Subsection (d-1) is not claimed by the owner before the 31st day after the date the owner is released from custody, the law enforcement agency holding the property shall deliver the property for disposition to a person designated by the municipality or to the purchasing agent or sheriff of the county in which the property was seized, as applicable. The person designated by the municipality, the purchasing agent, or the sheriff may sell or donate the property without mailing or publishing an additional notice as required by Subsection (b), (c), or (d). The sale proceeds, after deducting the reasonable expense of keeping and disposing of the property, must be deposited in the treasury of the municipality or county disposing of the property.

SECTION 2. Article 18.17, Code of Criminal Procedure, as amended by this Act, applies to personal property seized or taken into custody on or after the effective date of this Act. Personal property seized or taken into custody before the effective date of this Act is governed by the law in effect on the date the property is seized or taken into custody, and the former law is continued in effect for that purpose.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2013.

The chair in reviewing the bill finds that this classification scheme applies uniformly, is broad enough to include a substantial class or geographic area and that the membership of the class may expand or contract over time, and is based on characteristics that legitimately distinguish, in relation to the public purpose to be served, the class or area from other classes or areas. Therefore, the bill complies with the requirements of the Texas Constitution and Rule 8, Section 10 of the House Rules.

I just wanted to make sure that we had a little bit of legislative intent and that the main points of your bill are addressed here on the floor today. I think the points of your bill, one, would be less than a thousand gallons of water, correct?

REPRESENTATIVE CALLEGARI: Correct.

LUCIO: And that spill cannot reach a state waterway, nor could it adversely affect drinking water, correct?

CALLEGARI: That's correct. It'd be water or either semi-treated or untreated wastewater. Yes.

LUCIO: So, what your exemption would be is when there is a very quick, very minor spill that doesn't adversely affect drinking water or state waterways, that's immediately repaired, and it's not your intent—my understanding—that you're trying to lessen the requirements of those who knowingly pollute our waterways?

CALLEGARI: That is correct, absolutely not, yes. The intent is just to allow them to make the—try to treat it as best they can and make sure it's under control and it doesn't go into any public water.

LUCIO: And given that we've cut resources to TCEQ and other state agencies, we like them to focus on issues that are more pressing and not be involved in minor issues like this, so they're addressed correctly and they don't adversely affect our environment, correct?

CALLEGARI: That's correct, yes.

#### REMARKS ORDERED PRINTED

Representative Lucio moved to print remarks between Representative Callegari and Representative Lucio.

## SB 1792 ON SECOND READING (Phillips - House Sponsor)

**SB 1792**, A bill to be entitled An Act relating to remedies for nonpayment of tolls for the use of toll projects; authorizing a fee; creating an offense.

SB 1792 was considered in lieu of HB 3048.

#### Amendment No. 1

Representative Phillips offered the following amendment to **SB 1792**:

Amend SB 1792 (house committee printing) as follows:

- (1) On page 2, lines 26-27, strike "in the same manner as provided by general law for a private litigant".
  - (2) On page 3, line 22, strike "shall" and substitute "may".
  - (3) On page 6, strike lines 11-14 and substitute:
- (c) A party requesting a hearing shall pay a filing fee of \$100 to the clerk of the justice court. If that party prevails under the justice's finding under Subsection (f), the other party shall reimburse the prevailing party for the amount of the filing fee within 10 days after issuance of the finding.
  - (4) On page 11, between lines 4 and 5, insert:
- (c) For the purposes of Section 2303.155(b)(4), Occupations Code, fees required to be submitted to a governmental entity include an amount for unpaid tolls and fees owed by the registered owner of an impounded vehicle as set out in timely written notice given by the toll project entity to the operator of the vehicle storage facility where the vehicle is impounded. The toll project entity may set out in that notice an amount less than all unpaid tolls and fees owed by the registered owner without releasing the registered owner from liability under any other law for the full amount of unpaid tolls and fees.
  - (5) On page 12, line 4, strike "five" and substitute "two".

- (6) On page 13, line 17, strike "A reasonable fee not to exceed \$100 may be" and substitute "A filing fee of \$100 shall be".
  - (7) On page 13, lines 18-19, strike "as court costs".

(8) Strike page 13, line 21, and substitute:

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2013.

Amendment No. 1 was adopted.

## Amendment No. 2

Representative Stickland offered the following amendment to **SB 1792**:

Amend SB 1792 (house committee printing) on page 12, between lines 22 and 23, by inserting:

Sec. 372.116. TEMPORARY GRACE PERIOD FOR REGIONAL TOLEWAY AUTHORITIES. (a) Not later than the 30th day after the effective date of this subchapter, a regional tollway authority shall send to each person the authority determines to be a habitual violator on the effective date of this subchapter the notice required by Section 372.106(b).

(b) The notice under Subsection (a) must also include:

- (1) the total amount the person would owe for the events of nonpayment in the notice, not including any otherwise applicable administrative fees or penalties; and
- (2) information regarding the terms of the grace period under this section.
- (c) Not later than the 90th day after the effective date of this subchapter, a person who receives notice under this section may:

(1) request a hearing under Section 372.107; or

- (2) become an electronic toll collection customer of the regional tollway authority and:
- (A) pay the amount specified under Subsection (b) plus an administrative fee in an amount not to exceed 10 percent of the amount specified under Subsection (b); or
- (B) enter into a contract under Section 372.103 to pay the amount specified under Subsection (b) plus an administrative fee in an amount not to exceed 10 percent of the amount specified under Subsection (b).
- (d) A regional tollway authority may not pursue habitual toll violator remedies under this subchapter against a person who becomes an electronic toll collection customer and:
- (1) pays the amount specified under Subsection (b) plus an administrative fee in an amount not to exceed 10 percent of the amount specified under Subsection (b); or
- (2) enters into a contract under Section 372.103 to pay the amount specified under Subsection (b) plus an administrative fee in an amount not to exceed 10 percent of the amount specified under Subsection (b) and makes the required payments.
  - (e) This section expires August 31, 2015.

Amendment No. 2 was adopted.

SB 1792, as amended, was passed to third reading. (Schaefer and Simpson recorded voting no.)
