### **HB 6 - REMARKS**

REPRESENTATIVE SIMPSON: Can you tell me, Mr. Otto—first of all, thank you for your work on this. I appreciate the reduction, and the amount of funds that we're undedicating and consolidating. Can you tell me how much GR dedicated funds do you anticipate needing to certify the budget for this biennium?

REPRESENTATIVE OTTO: I cannot tell you at this time because we don't have a conference committee report on the budget. What I can tell you is that it will not exceed \$4 billion if this bill is passed through both chambers and the governor signs it.

SIMPSON: Okay, so it still could use up to \$4 billion to authorize other spending, basically?

OTTO: It could still use \$4 billion—the comptroller could still use \$4 billion for certification purposes.

SIMPSON: Can you explain certification, what that means?

OTTO: Well, certification is basically her taking a look at what the beginning balances that she estimated are, looking at all of the projected revenues to come in, as well as the fees and stuff associated with GRD accounts, then looking at the appropriations process, of what the bodies passed in the way of a budget and supplemental appropriations bills, and then determining how much of the balances that she's estimating to be there, how much of the GRD balances does she need in order for the revenues to equal the expenditures, taking into account what she started with.

SIMPSON: So, when we take the dedicated funds and undedicate them with this bill, are we basically using those funds to authorize other spending?

OTTO: No, only an appropriation can authorize the other spending.

SIMPSON: Well, I understand that, but if there's no revenue source for certain appropriations, that they need to use some of these funds that are being undedicated, is that what they rely on, a portion of them?

OTTO: Representative Simpson, I think we need to be really clear here that these funds are not used, they're not spent for purposes other than for which they are created. What we're talking about is a balance at a point in time—it's sort of like if you were to sit down and adopt a family household budget, you're only looking at do I need my savings account, and that's maybe a bad example, but do I need some of these GRD balances in order to certify the budget.

SIMPSON: Okay. How much dedicated funds do we have at this time?



OTTO: The estimate that I got yesterday—and this constantly changes, as things are fluid in both chambers—right now they are estimating that we would have about \$5.3 billion.

SIMPSON: Okay, so we're going to authorize up to four of the \$5.3 billion?

OTTO: And last session, there was approximately \$5 billion and we used the entire \$5 billion to certify the budget.

SIMPSON: One other question, and it has to do with this bill, but we're getting ready to come to another bill, **HB 7**—will this bill take precedence over **HB 7**?

OTTO: This bill has nothing to do with **HB 7**. This bill has solely to do with what amount the comptroller may use for certification purposes. **HB 7** is going to be dealing with the activity within certain designated GR accounts as to what the fee structure is going to be, what the amount that's going to be expended—**HB 6** has nothing to do, essentially, with **HB 7** other than the fact we're both dealing with GR dedicated accounts, but **HB 6** is solely related to what the comptroller may use in the balances for certification.

SIMPSON: All right, so this will not take precedence over or affect **HB 7**?

OTTO: This has no effect other than to tell the comptroller how much GRD balances she may use for certification.

SIMPSON: Okay. What does it mean, in Section 2 of the bill, it talks about abolition of funds, accounts, and dedications?

OTTO: Section 2 of the bill would consolidate new accounts, revenue created by the 83rd Legislature into GR that are not specifically exempted. That's the list we talked about, there's going to be a list that will be put on this bill, just like for the Dawson fund, that's going to exempt it from being consolidated.

SIMPSON: But we don't know what that list is now?

OTTO: We do not at this time because there are bills that are still passing, some of which may still create new designated GR accounts.

SIMPSON: Well, I appreciate the effort, and identifying the problem of using dedicated funds for other—and undedicating. When you read the caption of this bill, it looks like I'm in D.C. Is it relating to the creation and re-creation of funds and accounts in the state treasury, the dedication and rededication of revenue, the exemption of unappropriated money for the use of general governmental purposes?

OTTO: Representative Simpson, that's been the caption on this bill for a very, very long time, and I understand how it can be misleading.

SIMPSON: For 21 years, and I guess, it appears to me kind of a wizard bill, you know? We can't really look beyond the curtain to see how these funds are really—we're dedicating them and then undedicating them. We're saying we're not spending them, but we have to reduce, not use the dedicated accounts so we can actually make appropriations of general revenue.

OTTO: All I can tell you is, when the day comes that we no longer, when this is reduced to zero—and that day will come—we will not be going through this anymore.

SIMPSON: That's good, I think that's an admirable goal.

(a) The commission may issue a permit pursuant to Section 27.011 that authorizes the construction and operation of two or more similar injection wells within a specified area for mining of uranium. An application for a new permit issued pursuant to Section 27.011, a major amendment of such a permit, or a renewal of such a permit for mining of uranium is subject to the public notice requirements and opportunity for contested case hearing provided under Section 27.018. A new, amended, or renewal area permit must incorporate a table of pre-mining low and high values representing the range of groundwater quality within the area of review, as provided by commission rule, for each water quality parameter used to measure groundwater restoration in a commission-required restoration table. The values in the area permit range table must be established from all available wells within the area of review, including those in the existing or proposed area permit boundary and existing or proposed production area.

Wells used for this purpose are limited to those that have documented completion depths and screened intervals that correspond to a uranium production zone aquifer identified within an area permit boundary.

(c) The commission may issue a holder of a permit issued pursuant to Section 27.011 for mining of uranium an authorization that allows the permit holder to conduct mining and restoration activities in production zones within the boundary established in the permit. The commission by rule shall establish application requirements, technical requirements, including the methods for determining restoration table values, and procedural requirements for any authorization. If a restoration table value for a proposed authorization exceeds the range listed in the area permit range table, such that it falls above the upper limit of the range, the value within the area permit range table must be used or a major amendment to the area permit range table must be made, subject to a contested case hearing or the hearing requirements of Chapter 2001, Government Code.

(d) Notwithstanding Sections 5.551, 5.556, 27.011, and 27.018, an application for an authorization [~~submitted after September 1, 2007,~~] is an uncontested matter not subject to a contested case hearing or the hearing requirements of Chapter 2001, Government Code, if:

(1) the authorization is located within a permit that incorporates a range of groundwater quality restoration values used to measure groundwater restoration by the commission;

(2) the application includes groundwater quality restoration values within the range established in Subdivision (1); and

(3) the authorization is located within a permit that incorporates groundwater monitoring characteristics of the monitoring wells for the application required by commission rule [~~unless the authorization seeks any of the following:~~

(1) an amendment to a restoration table value;

(2) the initial establishment of monitoring wells for any area covered by the authorization, including the location, number, depth, spacing, and design of the monitoring wells, unless the executive director uses the recommendation of an independent third party expert chosen by the commission; or

(3) an amendment to the type or amount of bond required for groundwater restoration or by Section 27.073 to assure that there are sufficient funds available to the state for groundwater restoration or the plugging of abandoned wells in the area by a third party contractor].

(e) The range of restoration values in the range table used for Subsection (d) must be established from all available well sample data collected in the area of review [~~The executive director may use an independent third party expert if:~~

(1) the expert meets the qualifications set by commission rules for such experts;

(2) the applicant for the authorization agrees to pay the costs for the work of the expert; and

(3) the applicant for the authorization is not involved in the selection of the expert or the direction of the work of the expert].

(f) As an alternative to Subsection (d), the first application for an authorization issued under Subsection (c) located within a permit issued under Subsection (a) is subject to the requirements of Chapter 2001, Government Code, relating to opportunities for contested case hearings. The first application must contain the provisions listed in Subsections (d)(1)-(3). If a first authorization has previously been issued within a permit, that authorization is effective for the purposes of this subsection. A subsequent application for an authorization located within the same permit boundary is not subject to a contested case hearing or the hearing requirements of Chapter 2001, Government Code, unless the subsequent application would authorize the following:

(1) the use of groundwater from an aquifer outside the production zone aquifer for supplemental production water that was not previously approved in the permit;

(2) expansion of the permit boundary; or

(3) application monitoring well locations that exceed well spacing requirements or reduce the number of wells required by commission rule [An application seeking approval under Subsections (d)(1)-(3) is subject to the public notice and contested hearing requirements provided in Section 27.018].

(3) On page 2, lines 1 and 2, strike SECTION 2 of the bill and renumber the subsequent SECTIONS of the bill accordingly.

(4) On page 2, line 4, between "authorization" and "that is", insert "or a new, amended, or renewal permit".

(5) On page 2, line 6, strike "for an authorization".

(1) an electric customer eligible for the reduced rates determined under Subsection (j) is also eligible for reduced rates for telecommunications services offered for low-income customers; and

(2) a customer eligible for reduced rates for telecommunications services offered for low-income customers is also eligible for the reduced rates established under Subsection (j).

Amendment No. 5 was adopted.

(a) Notwithstanding Section 152.122, in each state fiscal year beginning on or after September 1, 2015, the comptroller shall deposit to the credit of the state highway fund an amount of money that is equal to 50 percent of the money that:

(1) is received under Sections 152.043, 152.045, 152.047, and 152.121 and is remaining after the comptroller makes the allocation required by Section 152.1222; and

(2) exceeds the first \$2.5 billion of money described by Subdivision (1) that is received in that fiscal year.

(b) Money deposited to the credit of the state highway fund under this section may be appropriated only:

(1) for a purpose authorized by Section 7-a, Article VIII, Texas Constitution;

(2) to repay the principal and interest on general obligation bonds issued as authorized by Section 49-p, Article III, Texas Constitution; or

(3) to pay for a function performed by or under the supervision of the Texas Department of Transportation.

Amendment No. 6 was withdrawn.

### **Amendment No. 7**

Representative P. King offered the following amendment to **CSHB 7**:

Amend **CSHB 7** by inserting new subsections (d) and (e) under SECTION 1 and renumbering subsequent subsections of the bill accordingly to read:

(d) For the purpose of reduction of reliance on available dedicated revenue for budget certification the board shall not set the rate of growth of appropriation as required by Government Code, Section 316.001 to exceed the lesser of:

(1) the revenue estimate required by Government Code, Section 403.121;

(2) the estimated rate of growth of the state's economy pursuant to Government Code, Section 316.002; or

(3) a rate equal to the sum of:

(A) the estimated biennial rate of growth of the state's population;

and

(B) the estimated biennial rate of monetary inflation in the state.

(e) The board shall determine the estimated biennial rate of growth of the state's population based on the average rate of growth during the preceding six years according to United States Census Bureau estimates as certified by the comptroller. The board shall determine the estimated biennial rate of monetary inflation in the state based on the average rate of change during the preceding six years of the effective consumer price index for the state. For purposes of this subsection, the effective consumer price index for the state is the average of the consumer price indexes as determined by the United States Department of Labor for the Corpus Christi metropolitan area and for the Dallas/Fort Worth metropolitan area.

#### **Amendment No. 7 - Point of Order**

Representative S. Turner raised a point of order against further consideration of Amendment No. 7 under Rule 11, Section 2 of the House Rules on the grounds that the amendment is not germane to the bill.

The chair overruled the point of order and submitted the following statement:

Representative S. Turner raised a point of order against further consideration of Amendment No. 7 to **HB 7** under Rule 11, Section 2 of the House Rules. The point of order is respectfully overruled.

**HB 7** directs the Legislative Budget Board to develop recommendations to reduce state government reliance on dedicated revenue for the purpose of budget certification. The bill further directs the board to incorporate into its recommendations measures to reduce state government reliance on dedicated revenue for the purpose of budget certification. Amendment No. 7 provides, for the purpose of reducing reliance on dedicated revenue for budget certification, that the board shall not set the rate of growth of appropriation above the lesser of three alternate caps and provides direction on how to calculate those caps. Because the amendment relates to the board's development of measures to reduce reliance on dedicated revenue to certify the budget, the amendment is germane. See Rule 11, Section 2 of the House Rules.

#### CSHB 7 - REMARKS

REPRESENTATIVE SIMPSON: Representative Darby, on page 8 of the fiscal note, right at the—towards the bottom there—right above where it says, "Local Government Impact," it speaks about, "This legislation would do one or more of the following"—you see that there?

REPRESENTATIVE DARBY: Which paragraph?

SIMPSON: It's the one right above "Local Government Impact" on page 8 or 9 of the fiscal note.

DARBY: Okay.

SIMPSON: Could you explain what that means there? We just passed **HB 6**, and it's certainly a related bill. What does this paragraph mean?

DARBY: I think it's talking about the petroleum storage fee.

SIMPSON: It says, "create or recreate a dedicated account in the General Revenue Fund, create or recreate a special or trust fund either within or outside of the Treasury." Seems to be referring to the whole bill—is that what it's referring to?

DARBY: Correct.

SIMPSON: Okay, can you explain what that means?

DARBY: I'm having trouble understanding why that paragraph is in there, because this bill does not create any new GR dedicated accounts.

SIMPSON: Well, it says within or without the Treasury, and I'm having a hard time understanding it, too.

DARBY: It seemed just like a general paragraph that they put in here, but it really doesn't apply to this bill, because this bill does not create any new general revenue dedicated accounts nor create any fund inside or outside the Treasury, except that—

SIMPSON: That's what it says, though.

DARBY: Except the system benefit fund. We're taking the low-income discount program and moving it outside the Treasury.

SIMPSON: Okay, but even according to **HB 6**, some funds outside the Treasury are subject to funds consolidation, and in Section 5 of that bill, it refers to that, even for trust funds outside the Treasury.

DARBY: Right.

SIMPSON: Can you tell me, the low-income electric consumers program and the fund that would be funded from—I believe from this bill, created—is that going to be subject to funds consolidation?

DARBY: No, it'll be outside the Treasury.

SIMPSON: But, I mean—but that doesn't necessarily mean that it doesn't apply.

DARBY: It's outside the Treasury, and it will simply fund the low-income discount program with an amount we collect. We're actually reducing the fee from 65 cents to 52 cents and taking it outside the Treasury and funding that program.

SIMPSON: Okay, so you're saying that it will not be subject to funds consolidation?

DARBY: I don't know. You know, Representative Otto's bill lists all of the accounts that will be subject to it. I don't know whether this fund will be included in that or not.

SIMPSON: It doesn't list them now?

DARBY: Yes.

SIMPSON: And, so, we're voting on things that we just really don't know what they're going to do, and this is what's so frustrating to me. We're being asked to vote for a bill to see what it's going to do.

DARBY: Representative Otto's bill speaks for itself, Representative Simpson.

SIMPSON: But this says it's subject, in my understanding, to funds consolidation. We're getting ready to create the Low-Income Electric Customers Program—basically a dedication—and I'm concerned that it's going to continue the same process that we're trying to fix by this bill, but this bill seems to be subject to the parameters and dictates the stipulations of **HB 6**.

DARBY: This account will be subject, just as all the other accounts will be subject—every dedicated account in this bill will be subject to the funds consolidation bill.

SIMPSON: So it can be consolidated—even these new dedicated accounts?

DARBY: I'm sorry, I missed that last—

SIMPSON: So, even these new dedicated accounts and programs created by this bill are going to be subject to it?

DARBY: Correct.

SIMPSON: All right, thank you.

The entity's ineligibility remains in effect until the last day of the sixth month after the date the drug test was administered.

(d) The comptroller shall use the most efficient and cost-effective drug use screening assessment tool that can be validated for purposes of this section.

(e) The comptroller shall adopt rules to implement this section.

(2) the proposed appropriations in **SB 1** may not be adjusted to reflect the revenue reductions that would result from the implementation of this Act; and

(3) the changes in law made by this Act have no effect and may not be implemented.

SECTION 2. Section 545.401, Transportation Code, is amended by amending Subsection (b) and adding Subsections (e), (f), and (g) to read as follows:



- (b) An offense under this section is a Class B misdemeanor ~~[punishable by:~~  
~~(1) a fine not to exceed \$200;~~  
~~(2) confinement in county jail for not more than 30 days; or~~  
~~(3) both the fine and the confinement].~~

(e) The court may:

(1) order that the driver's license of a person convicted of an offense under Subsection (a) be suspended for not less than 30 days or more than 180 days beginning on the date of conviction; and

(2) require the person to attend and present proof that the person successfully completed a driving safety course approved under Chapter 1001, Education Code, before the person's driver's license may be reinstated.

(f) A judge, acting under Article 42.12, Code of Criminal Procedure, who elects to place a defendant charged with an offense under Subsection (a) on community supervision under that article may require the defendant to attend and present proof that the defendant successfully completed a driving safety course approved under Chapter 1001, Education Code.

(g) A person who is subject to prosecution under both this section and another section of this or any other code may be prosecuted under either or both sections.

SECTION 3. The change in law made by this Act applies only to an offense committed on or after the effective date of this Act. An offense committed before the effective date of this Act is covered by the law in effect when the offense was committed, and the former law is continued in effect for that purpose. For purposes of this section, an offense was committed before the effective date of this Act if any element of the offense was committed before that date.

SECTION 4. This Act takes effect September 1, 2013.

Amendment No. 1 was adopted.

(b) A victim, guardian of a victim, or close relative of a deceased victim who would have been entitled to notification of parole consideration by the division but failed to provide a victim impact statement containing the person's name and address may file with the division a written request for notification. After receiving the written request for notification, the division shall grant to the person all privileges, including notification under this section, to which the person would have been entitled had the person submitted a completed victim impact statement.

(b-1) Regardless of whether a victim, guardian of a victim, or close relative of a deceased victim provided a victim impact statement or indicated on the statement that the person did or did not wish to be notified of any parole hearing for the defendant, the victim, guardian, or close relative may file with the division a written protest to notification indicating:

(1) that the person wishes to be notified of any parole hearing for the defendant; or

(2) that the person does not wish to receive any notification concerning the release of the defendant on parole but rather protests any subsequent release of the defendant on parole and wishes to receive notification of the defendant's release on parole.

(b-2) Notwithstanding any provision of Chapter 56, Code of Criminal Procedure, a victim, guardian of a victim, or close relative of a deceased victim may file a protest of notification described by Subsection (b-1) at any time, including immediately after a judgment is entered in the case.

(e) Before an inmate is released from the institutional division on parole or to mandatory supervision, the pardons and paroles division shall give notice of the release to a person entitled to notification of parole consideration for the inmate under Subsection (a) or (b), unless the person has filed with the division a written protest under Subsection (b-1) and has not withdrawn that protest.

Amendment No. 1 was adopted.
