Your strength that you gave Ken and me during last session was amazing. I want to thank you. It is an honor to serve with you and to close this day in honor of three incredible women. We are truly blessed.

REPRESENTATIVE KACAL: Members, thank you for your attention as we memorialize our mothers and our friend Andrea Sloan. I would also like to point out one of our family members here in the house, the wife of Isaac Paredes, Dorothy Paredes, who is in the gallery with us today on our left. Dorothy is in the middle of this battle, and the strength of the three women we honor is what carries us on to help women that surround us all. The common thread that each of these women shared was ovarian cancer. It's a cancer that we know so little about, but we have quickly learned that it is a silent killer. As a result, we have directed our grief and devastation into something positive—the formation of KK125 Ovarian Cancer Research Foundation. Our goals at the foundation are threefold: prevention and early detection, to advance treatment and a cure for the disease, and to educate people about compassionate use policy. Just this morning, I filed **HB 21**, the Right To Try Act. This bill will expedite a terminal patient's right to seek and receive experimental treatments under the advice and supervision of their doctor when all FDA approved treatments have failed. I encourage all members to join in this effort and to sign as co-authors. The bottom line is we would love to have our mothers back, but the reality is that's just not going to happen. We started this foundation in honor of our mothers and our friend Andrea and in hopes of saving all of you from what we've been through.

REPRESENTATIVE K. KING: I just wanted to add on to early detection and prevention—the name KK125 obviously came from Kyle's and my mother's initials, but the CA 125 is a predeterminate, and that's one of our focuses, to give money toward that research. One thing that makes it the silent killer is most women don't know they've had it until it's too late because early detection is not an option. I'm shortly going to introduce some legislation that would direct insurance companies to offer women a choice to have the CA 125 and pay for it during their well woman exam. We can't bring our mothers back, but members, my female friends, my friends in the gallery, and to the women in my family; we can stop this from happening to you.

ADDRESS BY REPRESENTATIVE MENÉNDEZ ON A MATTER OF PERSONAL PRIVILEGE

The chair recognized Representative Menéndez who addressed the house on a matter of personal privilege, speaking as follows:

Members, I will promise you not to take long. This is my 15th year in the Texas House and my last day. This would be my first time to request a personal privilege speech. The reason is that I just want to say thank you. I want to say thank you to each and every one of you—Ruth, John, Sylvester, Alma, so many of you, I could go down the list. I want to say that earlier today, when we passed the resolutions in honor of Ken and Kyle's moms and Andrea Sloan, it was an exact moment in time that, for me, encapsulates what the Texas House of Representatives means. It means that we're a body; we're 150 men and women, are sent by the good people of Texas to represent all of them, because unfortunately when we're fighting, whether it's disease, or we're fighting malnutrition, or we're fighting congestion, or whatever the issue that we're fighting for that the people have sent us from home—I see Diego in the back—or if it's payday lenders. Whatever the issue is, we need to remember that we fight for one Texas. The men and women who live in our district, the children who grow up, the children who are born in our district, they're not born with parties. They're born Texans. They're born Americans. When we send our men and women off to war, and they put on their uniform, and they have that American flag, they all bleed red.

This has been a deliberative body that I've been very proud to be a part of for the last 15 years. There have been many, many times that we've had ardent and strident disagreements because we don't always agree on how we want to get where we want to get, but I believe in my heart that each and every one of you ran for office because you want a better Texas—a better Texas for our children; a better Texas for our senior citizens; a better Texas for our veterans. It has been a tremendous honor to work side by side with many of you. It is with a bittersweet emotion that I leave so many of you in this body because this is the people's house. And so many times, the folks up in the gallery don't always see the work that's actually taking place because so much of the work is in relationships. It's building those relationships that get us beyond the little letters at the end of our name. It's building the relationships that say, "My senior citizens in my district suffer the same problems as the senior citizens in John Otto's district." Those retired teachers, who gave 20 and 30 years of their lives to this state, who through no fault of their own don't have social security and have not seen a cost of living adjustment in over 20 years. Those are issues that cut across any party and any demographic in any part of the state. They impact us from the border to the Panhandle, from East Texas to West Texas. And so I don't want to say goodbye because I have the privilege to continue working with you, just in a different capacity. I wanted you to know that my heart and my office are open to each and every one of you. For any of you that have anything that you want to do to help make Texas better, I'm ready to put my shoulder next to yours and try to get the job done. Thank you for not just your attention today, but for the time away from your families, your compassion, and your passion for Texas.
