I'm proud to speak in memory of a son of the Texas Panhandle, my friend and former colleague, Phil Cates. For those of you who knew Phil, just to mention his name would bring a smile to your face. For those of you who missed meeting him, you really missed a treat. Phil grew up in the tiny town of Lefors, south of the Canadian River. He was first elected to the Texas House from his home district at the age of 23 in the landslide victory of two votes. Phil was already here when I arrived in 1973, and we served together until 1979. He was loved and respected by all of us who served with him in the house. That love and respect continued later during his many years as a popular lobbyist.

A strong Baptist, Phil lived his faith every single day of his life. Phil had a loving and loyal heart, and he never forgot his friends. He took great pride in his wonderful wife, Nancy, and his two sons, John and Andrew, and he happily took on the role of a mentor to many young people throughout his life. ADDRESS BY THE SPEAKER PRO TEMPORE

Representative D. Bonnen addressed the house, speaking as follows:

We're going to begin the local and consent calendar. I want to remind the members that Ms. Thompson—Chair Thompson, wants you to be alert and prepared when your bill comes up. The committee works hard to manage the floor to make sure that we're able to move the local and consent calendar through efficiently. It is the discretion of the chair whether a member desires to knock a bill off, whether they speak the full 10 minutes or not. Today, the discretion is that you will speak a full 10 minutes. Next week, we may have a different decision, but it is up to the chair to make that decision. If you have five signatures, those five signatures will be read so that the members have the ability to know who has requested their bill to be taken away from the calendar.

PARLIAMENTARY INQUIRY

REPRESENTATIVE VILLALBA: The 10 minutes that will have to be spoken, can you describe for us the content of that? Is there any particular rule or regulation that requires that that 10 minutes be comprised of content?

CHAIR (Speaker pro tempore in the chair): Mr. Villalba, like all speeches on the floor and most particularly from the back mic, they have to be on the bill.

VILLALBA: On the bill, relating to the bill, speaking about the bill, and only about the bill?

CHAIR: That is correct.

VILLALBA: What about esoteric discussions of why a bill may be proposed? Must it be specifically on the bill?

CHAIR: Correct.

ADDRESS BY REPRESENTATIVE S. THOMPSON

The chair recognized Representative S. Thompson who addressed the house, speaking as follows:

When a bill is knocked off a local and consent calendar, it comes back to Local and Consent Calendars. If it moves then to the general calendar, it is at the discretion of the Local and Consent Committee. If we place that bill back on the local and consent calendar for the second time and that bill is again knocked off, at that particular time, we are to send it to the general calendar. But this bill that Mr. Stickland knocked off will come back—according to the rules that we adopted in January 2015—back to Local and Consent Calendars. It is the committee's discretion whether or not at that time they want to reset that bill on the local and consent calendar or send it to the general calendar.

HB 463 (by Springer), A bill to be entitled An Act relating to the ability to mow, bale, shred, or hoe material on a state highway right-of-way. (Schaefer and Tinderholt recorded voting no.)

HB 495 (by Howard), A bill to be entitled An Act relating to the use of money from the permanent fund for health-related programs to provide grants to nursing education programs. (Crownover, Fallon, Flynn, Goldman, Phillips, Schaefer, Simmons, Springer, Tinderholt, and Wray recorded voting no.)

HB 504 (by Guillen), A bill to be entitled An Act relating to designating the second full week in September as Direct Support Professionals Week.

PARLIAMENTARY INQUIRY

REPRESENTATIVE STICKLAND: I would prefer to continue the questions to the author of the bill.

CHAIR (Speaker pro tempore in the chair): The challenge, Mr. Stickland, with that is that Mr. Clardy has yielded the floor.

STICKLAND: So what is the current status of the bill?

CHAIR: The status of the bill is that it's here before us with four minutes and 38 seconds having expired of conversation and doing math in my head would mean that you have five minutes and 22 seconds left to talk.

STICKLAND: Are we aware of any precedent where this has ever been done before? When a member intends to kill a bill, that they have been asked to stop questioning and come to the front?

CHAIR: Mr. Stickland, I could probably spend 10 minutes giving you the precedent of where this has happened.

STICKLAND: How much time is left from the 10 minutes did you say?

CHAIR: I said it was five minutes and 22 seconds.

STICKLAND: If I come up to the front microphone and speak against it does that count toward the 10 minutes required to kick a bill off the local and consent?

- CHAIR: I apologize, Mr. Stickland, if I was not clear, but that's exactly what is allowed. It is that Mr. Clardy has the opportunity to yield the floor and then you have the opportunity to come to the front mic and talk for the time you desire.

- (1) On page 1, line 6, strike "Subsection (b-1)" and substitute "Subsections (b-1) and (b-2)".
 - (2) On page 1, between lines 16 and 17, insert the following:
- (b-2) If an officer for public information for a political subdivision provides by e-mail an Internet location or uniform resource locator (URL) address as permitted by Subsection (b-1), the e-mail must contain a statement in a conspicuous font clearly indicating that the requestor may nonetheless access the requested information by inspection or duplication or by receipt through United States mail, as provided by Subsection (b).
