(b) Members of the board appointed under Subsection (a)(6) [(a)(7)] serve staggered two-year terms, with the terms of the members described by Subsections (a)(6)(A)-(E) [(a)(7)(A) (E)] expiring on February 1 of each odd-numbered year and the terms of the members described by Subsections (a)(6)(F)-(I) [(a)(7)(F) (I)] expiring on February 1 of each even-numbered year. A member may serve more than one term.

CSHB 1628 (by Johnson, Kuempel, Lucio, Capriglione, and Longoria), A bill to be entitled An Act relating to authorizing a credit union or other financial institution to conduct savings promotion raffles. (Stickland and E. S. Turner recorded voting no.) (Bell requested to be recorded voting no after the deadline established by Rule 5, Section 52 of the House Rules.)

CSHB 1628 - STATEMENT OF LEGISLATIVE INTENT

REPRESENTATIVE STICKLAND: Representative Johnson, can you tell us what you're trying to accomplish? It seems on the surface that we're allowing credit unions to have raffles.

REPRESENTATIVE JOHNSON: No, this allows banks and credit unions to be able to use their own funds to encourage people to open savings accounts by offering a prize if they open a savings account and deposit money into their savings account.

STICKLAND: We're not encouraging savings by-

JOHNSON: Yes, it's encouraging savings by allowing banks to use their marketing funds, not the actual—

STICKLAND: I just want to make sure that we're not encouraging savings by encouraging gambling through raffling.

JOHNSON: This is actually an anti-gambling bill. It encourages people to put their money into banks or credit unions and they actually receive—if possible—they're possibly eligible to receive money from the bank to encourage opening a savings account.

HB 2379 (by Bohac, Springer, Fletcher, and P. King), A bill to be entitled An Act relating to the liability of first responders who provide roadside assistance.

CSSB 1593 (Lucio - House Sponsor), in lieu of **HB 2529**, A bill to be entitled An Act relating to regulation of the sale of fireworks by certain municipalities. (Harless and Springer recorded voting no.)

HB 3424 (by Smithee), A bill to be entitled An Act relating to a central database containing information about certain individuals under guardianship. (Krause, Phillips, Stickland, and M. White recorded voting no.)

SB 1077 (Parker and Oliveira - House Sponsors), in lieu of **HB 3434**, A bill to be entitled An Act relating to the definition of "person" under the Uniform Commercial Code.

Representative Parker moved to lay **HB 3434** on the table subject to call, and the motion prevailed.

HB 3438 (by Riddle), A bill to be entitled An Act relating to the transfer of surplus or salvage state agency property.

SB 1233 (Oliveira - House Sponsor), in lieu of **HB 3479**, A bill to be entitled An Act relating to authorizing certain distributions of income from a nonprofit corporation to members of the corporation who are certain nonprofit corporations.

Representative Oliveira moved to lay **HB 3479** on the table subject to call, and the motion prevailed.

SB 1626 (Dukes - House Sponsor), in lieu of **HB 3539**, A bill to be entitled An Act relating to the regulation by a developer of the installation of solar energy devices in a residential subdivision. (C. Anderson, Flynn, Krause, Phillips, Simpson, Tinderholt, M. White, and Zedler recorded voting no.) (Bell requested to be recorded voting no after the deadline established by Rule 5, Section 52 of the House Rules.)

Representative Collier moved to lay HB 3539 on the table subject to call, and the motion prevailed.

CSHB 3577 (by Howard, Deshotel, Keffer, Phelan, and C. Anderson), A bill to be entitled An Act relating to the distribution of funds under the Texas Educational Opportunity Grant Program. (Goldman, Schaefer, Simmons, Stickland, Tinderholt, and E. S. Turner recorded voting no.) (Bell and Parker requested to be recorded voting no after the deadline established by Rule 5, Section 52 of the House Rules.)

CSHB 3651 (by Coleman and Walle), A bill to be entitled An Act relating to the manufacture, sale, distribution, possession, and use of drugs not approved by the United States Food and Drug Administration and the false representation that a substance is a drug approved by the United States Food and Drug Administration or intended for the prevention or treatment of diseases in humans; creating criminal offenses. (Krause, Phillips, Rinaldi, Schaefer, Simpson, Stickland, Tinderholt, and M. White recorded voting no.)

CSHB 3651 - STATEMENT OF LEGISLATIVE INTENT

REPRESENTATIVE SIMPSON: I was concerned about the possible broad interpretation. You don't intend to cover herbs or supplements in this bill, do you not?

REPRESENTATIVE COLEMAN: No, there's no intent to do that. The purpose of the bill is to deal with counterfeit drugs or drugs manufactured in another country that haven't gone through our FDA process, thereby they are sold in flea markets or other places. They may not contain what people want to buy. SIMPSON: But you're not including essential pills, herbs, or supplements that may not be FDA approved, but they're not artificial substances?

COLEMAN: No, these are pharmaceutical products—not herbs and supplements—we're talking about in this bill.

What has changed is people have become more knowledgeable of what the intent is of this legislation.

RINALDI: Thank you for clarifying that the text did not change but that some members may have been, as you said, confused about the bill because they had not read it and may want to change their votes now because they hadn't read the bill. Is that what you're saying?

Y. DAVIS: I'm saying that members indicated that some of them didn't understand it. Our goal is to put this bill in proper context—to say that these dollars that came in from a federal settlement because somebody did things wrong to Texans—that we ought to use some of those funds to make sure that people and companies from out of state will never have an opportunity to burn Texans like that again. That's what we're trying to do.

REPRESENTATIVE LEACH: I'd like to just follow up on my line of questioning from earlier, before local and consent, and see if I can get some clarification from the chair on Rule 6. Specifically, can you outline for the body the process for moving a bill up on the general state calendar.

SPEAKER STRAUS: Mr. Leach, there is not a process for moving a bill up on the calendar.

LEACH: There's no process for moving a bill earlier on a calendar?

SPEAKER: Only the Calendars Committee has that discretion.

LEACH: So is there no process under Rule 6, Sections 6 and 7, for a member of this body to bring a motion to move a bill on the calendar?

SPEAKER: Mr. Leach, Rule 6, Section 7, Section 6, and Section 2 provide a method for setting items on special order.

LEACH: Can a member move to suspend the rules to take up a bill out of its regular order?

SPEAKER: That is a motion to set a bill special order.

LEACH: If that happens, what impact does moving a bill up on the general calendar have on the other bills that are behind it on the calendar?

SPEAKER: It would place them behind.

LEACH: I'm just seeking clarification on this, they're placed behind the bill in their regular order?

SPEAKER: Mr. Leach, a special order is not on the calendar, but it's taken up as a matter of priority.

LEACH: Okay, and just for further clarification, what is the process, under Rule 6, to move a bill from the general calendar to the major state calendar?

SPEAKER: Mr. Leach, there is no process to do that except through the Calendars Committee.

LEACH: Can a member suspend the rules to move a bill from the general state calendar to the major state calendar if it has statewide impact?

SPEAKER: No.
