Amendment No. 1

Representative Klick offered the following amendment to **SB 142**:

Amend **SB 142** (house committee printing) in SECTION 1 of the bill, in added Section 13.048(a), Election Code, between "registrars" and "under this section" (page 1, line 10), by inserting "prescribed by the secretary of state or developed by the county and approved by the secretary of state".

Amendment No. 1 was adopted.

- **SB 147** (Hernandez House Sponsor), A bill to be entitled An Act relating to the violation of certain court orders or conditions of bond in a family violence, sexual assault or abuse, stalking, or trafficking case; providing penalties.
- **SB 168** (Farias House Sponsor), A bill to be entitled An Act relating to temporary waiver of superintendent certification for employment of public school district superintendents.
- **SB 183** (J. White House Sponsor), A bill to be entitled An Act relating to the offenses of the violation of civil rights of and improper sexual activity with individuals in custody; imposing a criminal penalty.
- **SB** 189 was withdrawn. (Pursuant to Rule 6, Section 14(3) of the House Rules, the following five members gave notice of their objection: Stickland, Tinderholt, Spitzer, Rinaldi, and Leach.) (The objections were later withdrawn, and **SB** 189 was passed to third reading.)
- **SB 287** (Smithee House Sponsor), A bill to be entitled An Act relating to the elimination of certain court fees and costs.

Amendment No. 1

Representative Smithee offered the following amendment to **SB 287**:

Amend **SB 287** by adding the following appropriately numbered SECTIONS to the bill and renumbering the subsequent SECTIONS of the bill accordingly:

SECTION _____. Article 103.001, Code of Criminal Procedure, is amended to read as follows:

- Art. 103.001. COSTS PAYABLE. (a) In a justice or municipal court, a [A] cost is not payable by the person charged with the cost until a written bill is:
- $\underline{(1)}$ produced or [is] ready to be produced, containing the items of cost; and
- (2) [-] signed by the officer who charged the cost or the officer who is entitled to receive payment for the cost.
- (b) In a court other than a justice or municipal court, a cost is not payable by the person charged with the cost until a written bill containing the items of cost is:
 - (1) produced;
- (2) signed by the officer who charged the cost or the officer who is entitled to receive payment for the cost; and
 - (3) provided to the person charged with the cost.
- SECTION ____. Article 103.001, Code of Criminal Procedure, as amended by this Act, applies only to a cost incurred on or after the effective date of this Act. A cost incurred before the effective date of this Act is governed by the law in effect on the date the cost was incurred, and the former law is continued in effect for that purpose.

Amendment No. 1 was adopted.

- **SB 382** (Huberty House Sponsor), A bill to be entitled An Act relating to public school educator continuing education credit for instruction on the use of an automated external defibrillator. (S. King recorded voting no.)
- **SB 394** (P. King and Springer House Sponsors), A bill to be entitled An Act relating to the use of supplemental environmental projects by a local government to come into compliance with environmental laws or remediate environmental harm caused by the local government.
- **SB 453** (Clardy House Sponsor), A bill to be entitled An Act relating to minimum scores required for public school students to receive credit by an examination administered through the College-Level Examination Program. (Flynn, Krause, Simpson, and Zedler recorded voting no.)
- **SB 507** was withdrawn. (Pursuant to Rule 6, Section 14(3) of the House Rules, the following five members gave notice of their objection: Stickland, Tinderholt, Shaheen, M. White, and Rinaldi.) (The objections were later withdrawn, and **SB 507** was amended and was passed to third reading.)

PARLIAMENTARY INQUIRY

REPRESENTATIVE S. THOMPSON: Was this a bill dealing with children with special needs in classrooms?

- CHAIR (Speaker pro tempore in the chair): Ms. Thompson, our understanding reading the caption is it relates to the placement and use of video cameras in self-contained classrooms providing special education services.
- S. THOMPSON: And these are children that, many times, cannot speak or have language impediments, and cameras were provided in order to protect them from injuries and things that may happen in the classroom, is that your understanding?
- CHAIR: Ma'am, I'm not aware of the details of the bill, but if you say so, I trust you.
- S. THOMPSON: Were you also aware that there were two amendments that would have taken care of some of the school district's problems as it's related to funding?
- CHAIR: Ms. Thompson, the chair is advised that there were two committee approved amendments that would have been put on this bill. I do not know the substance of those amendments, and I know that they were not given the opportunity to be presented.
- S. THOMPSON: So the lack of passage of this bill would mean those kids that are in those self-contained classrooms, and may be still subject to injuries and things—those parents won't know what happened to those kids because the kids cannot talk because they were born with the inability to speak and they cannot tell their parents what happened to them. The cameras would be able to visually tell them what caused the injuries that may have occurred inside the classroom. Is that correct?

CHAIR: Again, Ms. Thompson, I have not had an opportunity to review the bill.

- S. THOMPSON: And persons who have bumped this bill off don't care about kids with special needs and they don't care about the interests of those kids who have those disabilities in the classroom. So they want those kids to still be able to suffer those injuries in those classrooms.
- CHAIR: Ms. Thompson, maybe if you visited with some of the members about the amendments you wanted to offer, you could prevail upon those five members.
- S. THOMPSON: Mr. Speaker, there are some times you make a person live in the bed they have prepared for themselves. Since they want these kids still to be injured and still to suffer in these classrooms, I think they should live with consequences of this bill.
- **SB 550** (Rose House Sponsor), A bill to be entitled An Act relating to requiring dental support for a child subject to a child support order. (R. Miller and Schaefer recorded voting no.)
- **CSSB 551** (Keffer House Sponsor), A bill to be entitled An Act relating to the duty of the Water Conservation Advisory Council to submit a report and recommendations regarding water conservation in this state. (Rinaldi recorded voting no.)
- CSSB 630 (Dale House Sponsor), A bill to be entitled An Act relating to protective orders for certain victims of sexual assault or abuse, stalking, or trafficking.
- SB 638 (Otto House Sponsor), A bill to be entitled An Act relating to the transfer of certain state property from the Texas Department of Transportation to the Shepherd Independent School District; requiring the payment of certain transaction fees. (Cook, Craddick, Goldman, D. Miller, Parker, Simmons, Springer, and E. Thompson recorded voting no.) (Crownover and Zerwas requested to be recorded voting no after the deadline established by Rule 5, Section 52 of the House Rules.)
- **SB 674** (Coleman House Sponsor), A bill to be entitled An Act relating to instruction regarding mental health, substance abuse, and youth suicide in educator training programs. (Phillips recorded voting no.)
- SB 740 (Canales House Sponsor), A bill to be entitled An Act relating to the assessment of court costs and fees on conviction of multiple offenses or on conviction of multiple counts of the same offense. (C. Anderson, Cook, Craddick, Flynn, Goldman, Harless, D. Miller, R. Miller, Parker, Phillips, Simmons, Springer, E. Thompson, Tinderholt, M. White, and Zedler recorded voting no.) (Crownover and Zerwas requested to be recorded voting no after the deadline established by Rule 5, Section 52 of the House Rules.)

SB 740 - STATEMENT OF LEGISLATIVE INTENT

REPRESENTATIVE LOZANO: Is it the intent of the legislature that this bill would apply to bond forfeiture proceedings?

REPRESENTATIVE NEVÁREZ: Yes.

LOZANO: Since many counties treat bond forfeiture proceedings as civil cases, do you think that would make a difference in the application of this bill?

NEVÁREZ: No. Both the Texas Court of Criminal Appeals and the Supreme Court of Texas have held that a bond forfeiture case is a criminal case. In fact, it is a hearing in an existing case to which court costs already attach. With the exception of the citation and service of citation fees, the remaining court costs would be excluded by this bill.

LOZANO: Would this be a significant change in the law?

NEVÁREZ: No. There is no statute authorizing the collection of civil filing fees in a criminal bond forfeiture case. In fact, the courts of appeals in Texas were doing something similar and the Texas Court of Criminal Appeals held that this was in violation of the law and required them all to stop that practice.

REMARKS ORDERED PRINTED

SB 806 (S. King - House Sponsor), A bill to be entitled An Act relating to the College Credit for Heroes program.

SB 813 (Lucio - House Sponsor), A bill to be entitled An Act relating to the use of digitized signatures in certain family law proceedings.

SB 821 (Lucio - House Sponsor), A bill to be entitled An Act relating to references to school in the Family Code.

CSSB 825 (S. Thompson - House Sponsor), A bill to be entitled An Act relating to the prosecution of the offense of prostitution.

SB 830 (Dutton - House Sponsor), A bill to be entitled An Act relating to the creation of an independent ombudsman for children and youth in foster care. (E. S. Turner recorded voting no.)

SB 833 (S. King, et al. - House Sponsors), A bill to be entitled An Act relating to the continuation of a residence homestead exemption from ad valorem taxation while the owner is temporarily absent because of military service.

REMARKS ORDERED PRINTED

Representative S. Turner moved to print remarks between Representative S. Thompson and the chair on **SB 507**.

The motion prevailed.

SB 950 was withdrawn and, pursuant to Rule 6, Section 24 of the House Rules, was returned to the Committee on Local and Consent Calendars. (Pursuant to Rule 6, Section 14(3) of the House Rules, the following five members gave notice of their objection: Stickland, Tinderholt, M. White, Rinaldi, and Spitzer.)

REASONS FOR OBJECTION

I voted to remove **SB 950** from the calendar. Our first duty is to protect innocent children and innocent adults. The law as written is overly broad and may prohibit good people from living with children. I will continue to work with the author to continue to protect the people of Texas.

Spitzer

I voted to move this bill from local and consent because currently the bill is too broad and doesn't go far enough to protect children or the potentially innocent adults. I will work with the authors to make this a better and more robust bill. Protecting children from abuse is of the utmost importance.

Tinderholt

After reading loosely written language on **SB 950** that could be used to hurt an innocent person falsely accused of abuse of a child, I decided to vote to kill the bill. While I am a huge supporter of protecting women, children, the elderly, disabled, and everyone from abuse and neglect, I have to make sure that language protects the innocent and convicts the guilty. I spoke to the bill's author, Chairman S. Thompson, about my concerns. After she reread the language, she agreed with me and thanked me for bringing it to her attention. I look forward to working with the author next session to present a bill that will indeed protect the innocent from the guilty.

CHAPTER 7950. F.M. 2920/BECKER ROAD MUNICIPAL UTILITY DISTRICT OF HARRIS COUNTY

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 7950.001. DEFINITIONS. In this chapter:

- (1) "Board" means the district's board of directors.
- (2) "Commission" means the Texas Commission on Environmental Quality.
 - (3) "Director" means a board member.
- (4) "District" means the F.M. 2920/Becker Road Municipal Utility District of Harris County.

Sec. 7950.002. NATURE OF DISTRICT. The district is a municipal utility district created under Section 59, Article XVI, Texas Constitution.

Sec. 7950.003. CONFIRMATION AND DIRECTORS' ELECTION REQUIRED. The temporary directors shall hold an election to confirm the creation of the district and to elect five permanent directors as provided by Section 49.102, Water Code.

Sec. 7950.004. CONSENT OF MUNICIPALITY REQUIRED. The temporary directors may not hold an election under Section 7950.003 until each municipality in whose corporate limits or extraterritorial jurisdiction the district is located has consented by ordinance or resolution to the creation of the district and to the inclusion of land in the district.

Sec. 7950.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a) The district is created to serve a public purpose and benefit.

- (b) The district is created to accomplish the purposes of:
- (1) a municipal utility district as provided by general law and Section 59, Article XVI, Texas Constitution; and
- (2) Section 52, Article III, Texas Constitution, that relate to the construction, acquisition, improvement, operation, or maintenance of macadamized, graveled, or paved roads, or improvements, including storm drainage, in aid of those roads.

- Sec. 7950.006. INITIAL DISTRICT TERRITORY. (a) The district is initially composed of the territory described by Section 2 of the Act enacting this chapter.
- (b) The boundaries and field notes contained in Section 2 of the Act enacting this chapter form a closure. A mistake made in the field notes or in copying the field notes in the legislative process does not affect the district's:
 - (1) organization, existence, or validity;
- (2) right to issue any type of bond for the purposes for which the district is created or to pay the principal of and interest on a bond;
 - (3) right to impose a tax; or
 - (4) legality or operation.

SUBCHAPTER B. BOARD OF DIRECTORS

Sec. 7950.051. GOVERNING BODY; TERMS. (a) The district is governed by a board of five elected directors.

- (b) Except as provided by Section 7950.052, directors serve staggered four-year terms.
- Sec. 7950.052. TEMPORARY DIRECTORS. (a) The temporary board consists of:
 - (1) Brian Toldan;
 - (2) Elva Composto;
 - (3) Hudson Kennedy;
 - (4) Josh Rambo; and
 - (5) Michael Others.
 - (b) Temporary directors serve until the earlier of:
 - (1) the date permanent directors are elected under Section 7950.003; or
- (2) the fourth anniversary of the effective date of the Act enacting this chapter.
- (c) If permanent directors have not been elected under Section 7950.003 and the terms of the temporary directors have expired, successor temporary directors shall be appointed or reappointed as provided by Subsection (d) to serve terms that expire on the earlier of:
 - (1) the date permanent directors are elected under Section 7950.003; or
- (2) the fourth anniversary of the date of the appointment or reappointment.
- (d) If Subsection (c) applies, the owner or owners of a majority of the assessed value of the real property in the district may submit a petition to the commission requesting that the commission appoint as successor temporary directors the five persons named in the petition. The commission shall appoint as successor temporary directors the five persons named in the petition.

SUBCHAPTER C. POWERS AND DUTIES

Sec. 7950.101. GENERAL POWERS AND DUTIES. The district has the powers and duties necessary to accomplish the purposes for which the district is created.

Sec. 7950.102. MUNICIPAL UTILITY DISTRICT POWERS AND DUTIES. The district has the powers and duties provided by the general law of this state, including Chapters 49 and 54, Water Code, applicable to municipal utility districts created under Section 59, Article XVI, Texas Constitution.

Sec. 7950.103. AUTHORITY FOR ROAD PROJECTS. Under Section 52, Article III, Texas Constitution, the district may design, acquire, construct, finance, issue bonds for, improve, operate, maintain, and convey to this state, a county, or a municipality for operation and maintenance macadamized, graveled, or paved roads, or improvements, including storm drainage, in aid of those roads.

Sec. 7950.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road project must meet all applicable construction standards, zoning and subdivision requirements, and regulations of each municipality in whose corporate limits or extraterritorial jurisdiction the road project is located.

- (b) If a road project is not located in the corporate limits or extraterritorial jurisdiction of a municipality, the road project must meet all applicable construction standards, subdivision requirements, and regulations of each county in which the road project is located.
- (c) If the state will maintain and operate the road, the Texas Transportation Commission must approve the plans and specifications of the road project.

Sec. 7950.105. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE OR RESOLUTION. The district shall comply with all applicable requirements of any ordinance or resolution that is adopted under Section 54.016 or 54.0165, Water Code, and that consents to the creation of the district or to the inclusion of land in the district.

SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

Sec. 7950.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The district may issue, without an election, bonds and other obligations secured by:

- (1) revenue other than ad valorem taxes; or
- (2) contract payments described by Section 7950.153.
- (b) The district must hold an election in the manner provided by Chapters 49 and 54, Water Code, to obtain voter approval before the district may impose an ad valorem tax or issue bonds payable from ad valorem taxes.
- (c) The district may not issue bonds payable from ad valorem taxes to finance a road project unless the issuance is approved by a vote of a two-thirds majority of the district voters voting at an election held for that purpose.
- Sec. 7950.152. OPERATION AND MAINTENANCE TAX. (a) If authorized at an election held under Section 7950.151, the district may impose an operation and maintenance tax on taxable property in the district in accordance with Section 49.107, Water Code.
- (b) The board shall determine the tax rate. The rate may not exceed the rate approved at the election.
- Sec. 7950.153. CONTRACT TAXES. (a) In accordance with Section 49.108, Water Code, the district may impose a tax other than an operation and maintenance tax and use the revenue derived from the tax to make payments under a contract after the provisions of the contract have been approved by a majority of the district voters voting at an election held for that purpose.

(b) A contract approved by the district voters may contain a provision stating that the contract may be modified or amended by the board without further voter approval.

SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

Sec. 7950.201. AUTHORITY TO ISSUE BONDS AND OTHER OBLIGATIONS. The district may issue bonds or other obligations payable wholly or partly from ad valorem taxes, impact fees, revenue, contract payments, grants, or other district money, or any combination of those sources, to pay for any authorized district purpose.

Sec. 7950.202. TAXES FOR BONDS. At the time the district issues bonds payable wholly or partly from ad valorem taxes, the board shall provide for the annual imposition of a continuing direct ad valorem tax, without limit as to rate or amount, while all or part of the bonds are outstanding as required and in the manner provided by Sections 54.601 and 54.602, Water Code.

Sec. 7950.203. BONDS FOR ROAD PROJECTS. At the time of issuance, the total principal amount of bonds or other obligations issued or incurred to finance road projects and payable from ad valorem taxes may not exceed one-fourth of the assessed value of the real property in the district.
