REASON FOR VOTE

Under current law, Chapter 264 of the Family Code provides for a caregiver assistance agreement for families of children in the CPS system to care for their relatives. As the authors of **HB 4** note, the families who participate in the kinship program receive less payment than non-relatives in the system. This bill attempts to help offset the cost to families of taking in relatives in the system by increasing the amount of money they are eligible to receive. This is a laudable goal.

There are, however, as many as 200,000 children in our state being cared for by relatives outside the CPS or foster care system. These relatives take on this responsibility without help from the government or being subject to inspection or regulation by the state, out of love for their relatives and a sense of familial duty. I am concerned that by increasing the amount of money families can receive from the state for caring for the children of their relatives, we likely will create the perverse incentive for families who currently care for relatives outside the state

system to inject the children into the system in order to qualify for the financial aid, thus subjecting themselves to regulation by the state and interposing the state between children in need and their relatives.

Although I am voting for the bill in the hope that the authors are correct that this will not be the result, my concern is that past experience with programs such as AFDC have shown that government programs can create unanticipated incentives that can be detrimental to the families they are designed to aid.
