### CSHB 76 ON SECOND READING (by Huberty, Cain, Ashby, and M. González)

**CSHB 76**, A bill to be entitled An Act relating to cardiac assessments of high school participants in extracurricular athletic activities sponsored or sanctioned by the University Interscholastic League.

**CSHB** 76 was passed to engrossment.

## CSHB 123 ON SECOND READING (by White, Klick, Miller, Minjarez, Rose, et al.)

**CSHB 123**, A bill to be entitled An Act relating to personal identification documents for foster children or youth, homeless children or youth, and unaccompanied youth.

### Amendment No. 1

Representative White offered the following amendment to **CSHB 123**:

Amend CSHB 123 (house committee report) as follows:

- (1) On page 1, line 8, strike "OR UNACCOMPANIED" and substitute "CHILD OR".
- (2) On page 1, lines 12 and 13, strike "or an unaccompanied youth as those terms are" and substitute "as".
- (3) On page 2, line 1, strike ", HOMELESS CHILD OR YOUTH, OR UNACCOMPANIED" and substitute "OR HOMELESS CHILD OR".
  - (4) Strike page 2, lines 14 and 15.
- (5) On page 2, lines 17 and 18, strike ", a homeless child or youth, or an unaccompanied" and substitute "or a homeless child or".
  - (6) On page 3, line 2, strike "or an unaccompanied youth".
- (7) On page 3, lines 25 and 26, strike ", HOMELESS CHILD OR YOUTH, OR UNACCOMPANIED" and substitute "OR HOMELESS CHILD OR".
- (8) On page 4, lines 8 and 9, strike "or an unaccompanied youth as those terms are" and substitute "as".
- (9) Add the following appropriately numbered SECTIONS to the bill and renumber the SECTIONS of the bill as appropriate:
- SECTION \_\_\_\_\_. Section 264.121, Family Code, is amended by adding Subsection (e-3) to read as follows:
- (e-3) When obtaining a copy of a birth certificate to provide to a foster youth or assisting a foster youth in obtaining a copy of a birth certificate, the department shall obtain the birth certificate from the state registrar. If the department is unable to obtain the birth certificate from the state registrar, the department may obtain the birth certificate from a local registrar or county clerk.
- SECTION \_\_\_\_\_. Section 521.421, Transportation Code, is amended by adding Subsection (k) to read as follows:

- (k) A person applying for the issuance or renewal of a license, including a duplicate license or a license issued or renewed over the Internet or by other electronic means, may elect to contribute \$1 or more to the identification fee exemption account established under Section 521.4265.
- SECTION . Section 521.422, Transportation Code, is amended by adding Subsection (d) to read as follows:
- (d) A person applying for the issuance or renewal of a personal identification card, including a duplicate personal identification card or a personal identification card issued or renewed over the Internet or by other electronic means, may elect to contribute \$1 or more to the identification fee exemption account established under Section 521.4265.
- SECTION . Subchapter R, Chapter 521, Transportation Code, is amended by adding Section 521.4265 to read as follows:
- Sec. 521.4265. IDENTIFICATION FEE EXEMPTION ACCOUNT. (a) The identification fee exemption account is created as an account in the general revenue fund of the state treasury. The fund consists of grants and donations made to the department for the purposes of this section, including donations received under Sections 521.421(k) and 521.422(d). The department shall administer the account. Money in the account may be appropriated for the purposes of Subsection (b).
- (b) For each exemption granted under Section 521.1015 or 521.1811, the department shall deposit to the credit of the Texas mobility fund an amount from the identification fee exemption account under Subsection (a) that is equal to the amount of the waived fee that would otherwise be deposited to the mobility fund.
- (c) The department may not grant an exemption under Section 521.1015 or 521.1811 if money is not available in the identification fee exemption account to meet the requirements of Subsection (b).

Amendment No. 1 was adopted.

**HB 155**, A bill to be entitled An Act relating to notice provided to a court regarding a defendant confined in a state jail felony facility.

### Amendment No. 1

Amend **HB 155** (house committee report) by striking page 1, lines 5 through 12, and substituting the following:

SECTION 1. Article 42A.558, Code of Criminal Procedure, is amended by adding Subsections (b-1) and (b-2) to read as follows:

(b-1) On request of the judge, the Texas Department of Criminal Justice shall, not later than the 60th day after the date the defendant is received into the custody of a state jail felony facility, notify the judge of the date on which the defendant will have served 75 days in the facility. The notice must be provided by e-mail or other electronic communication.

(b-2) For purposes of Subsection (b-1), the judge may submit a single request to the Texas Department of Criminal Justice with respect to all applicable defendants sentenced in the judge's court.

Amendment No. 1 was adopted.

### PARLIAMENTARY INQUIRY

MARTINEZ FISCHER: If the parliamentary inquiry is related to a committee and a committee amendment, is it in the committee where the parliamentary inquiry is proper? And if it is, who would be presiding over that inquiry?

SPEAKER: If it's related to a committee amendment, you can ask a parliamentary inquiry of the committee chair. And you're also welcome to visit with the parliamentarians at any time.

MARTINEZ FISCHER: If the inquiry requires or would necessitate a ruling from the chair—and I guess in that instance it would be the committee chair—is there anyone to advise the committee chair on that ruling?

SPEAKER: Yes, it would be the parliamentarians who would be available to advise the chair.

MARTINEZ FISCHER: Okay, and so just for my purposes, what is the best way by which we need to ensure that the house parliamentarian is available to make that requisite ruling, given the number of committees and the overlapping committee times and so forth?

SPEAKER: You can call the parliamentarians' office at 3-2003, and they will be available to the best of their ability.

MARTINEZ FISCHER: And just in terms of the house practice for that, Mr. Speaker, in the event that that inquiry is made to the parliamentarians' office and they happen to be disposing of another similar matter or something of other urgent business, is the committee to wait at ease until the parliamentarian is available?

SPEAKER: That's not a proper parliamentary inquiry. You can visit with the parliamentarians' office.

MARTINEZ FISCHER: Mr. Speaker, parliamentary inquiry related to Rule 4, Section 40, I would imagine, as it relates to committee substitutes—is it the same response as it was for Section 39?

SPEAKER: Correct. It's not a proper parliamentary inquiry.

MARTINEZ FISCHER: And Mr. Speaker, just for my evening reading, could you give me the rule regarding the inappropriateness of this parliamentary inquiry so that I can become more familiar with it and I will be learned for the next time?

SPEAKER: You can review Mason's, Section 250-1.

MARTINEZ FISCHER: Is there a house rule?

SPEAKER: Rule 1, Section 9.

MARTINEZ FISCHER: Okay, thank you, so Rule 1, Section 9. And if you'd give me the *Mason's* section, I'd appreciate that.

SPEAKER: Section 250-1.
